Alameda CTC Transportation Forum Highlights Progress in Central County

Alameda County – California. On January 20, 2011, the Alameda County Transportation Commission (Alameda CTC), in partnership with its Citizens Advisory Committee and sponsoring agencies is holding a transportation forum at Hayward City Hall in Hayward. The forum will begin at 6:30 p.m. and is open to the public. It will focus on the agency's major transportation projects and programs in the county's central region.

The event will highlight projects and programs that aim to reduce congestion and improve access and mobility. Formal presentations include:

- **Alameda CTC and Local Transportation Plans**

Meet Alameda County's newly-formed countywide transportation agency and hear about the countywide transportation planning efforts and development of a new transportation expenditure plan that will address greenhouse gas reductions.

- **Senior Travel Training**

Alameda County is on the cutting edge in preparing for the coming "boom" in the senior-aged population, with numbers that are expected to more than double in the next twenty years. Hear about efforts that support mobility opportunities for seniors and people with disabilities.

- **I-880 Corridor Improvements**

Many projects are underway to improve the efficiency of the I-880 Corridor. This presentation will cover corridor improvements through Central Alameda County.

- **Route 238 Improvements**

Construction began earlier this year on Route 238, making significant improvements through Hayward. Construction activities and plans regarding the project's final implementation will be presented.

- **Lewelling/East Lewelling Project**

The first of a two-phase project to widen East Lewelling Boulevard to East 14th Street and to move utilities underground in the project area. Construction widens Lewelling Boulevard between Hesperian Boulevard and Meekland Avenue and also includes streetscape improvements.
