The Alameda CWTP is a long-range policy document that guides transportation funding decisions for Alameda County's transportation system over the next 25 years. The TEP is the Alameda County halfcent transportation sales tax initiative, currently known as Measure B. As a key source of local funding, the TEP funds transportation projects and programs, such as operations and maintenance, in Alameda County.

The CWTP is being updated to address legislative and regulatory changes in transportation, as well as changing demographics and economic trends and to address current and future transportation needs. The CWTP will also provide a framework and guidelines for transportation planning in accordance with regional goals and planning policy requirements.

**Key issues** to be addressed in the planning process include:

- **Planning for a multi-modal system** that equitably moves people and goods efficiently and cost effectively throughout the County;
- Planning for the full range of travel needs and the diversity of users of our transportation system;
- Integrating new legislation that requires greater coordination between transportation and landuse planning and a focus on reducing Vehicle Miles Travelled (VMT) and greenhouse gas emissions;
- **Considering the maintenance of the existing system** and potential system expansions.

## Other Ways to Get Involved
