INDEPENDENT ACCOUNTANT'S REPORT

We have examined the San Francisco Bay Area Rapid Transit District's (District) compliance with the types of compliance requirements described in the Measure B Sales Tax for Mass Transit Funds Agreement (Agreement) between the District and the Alameda County Transportation Commission (ACTC) applicable to the Measure B funds program that were allocated to the District for the fiscal year ended June 30, 2011. Measure B sales tax revenues and related expenses are included in the accompanying Schedule of Revenues and Expenses of Measure B Funds. Management is responsible for the District's compliance with those requirements. Our responsibility is to express an opinion on the District's compliance based on our examination.

Our examination was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants and, accordingly, included examining, on a test basis, evidence about the District's compliance with those requirements and performing such other procedures as we considered necessary in the circumstances. We believe that our examination provides a reasonable basis for our opinion. Our examination does not provide a legal determination on the District's compliance with specified requirements.

Our examination disclosed the following instance of a material noncompliance with the reporting requirements as described in procedure #12 of the Agreement. The Semi-Annual Year-End Compliance Report was filed timely, but it was missing certain required information. This report was subsequently corrected through amendments and revisions.

In our opinion, except for the instance of material noncompliance described in the third paragraph, the District complied, in all material respects, with the aforementioned requirements that are applicable to the Measure B funds as specified in the Agreement for the fiscal year ended June 30, 2011.

This report is intended solely for the information and use of the District's Board of Directors, the District's management, and ACTIA and is not intended to be and should not be used by anyone other than these specified parties.
