1. Welcome and Introductions

Paratransit Coordinator Naomi Armenta called the meeting to order at 9:35 a.m. The meeting began with introductions and a review of the meeting outcomes.

Guests Present: Jeff Weiss, Bay Area Community Services (BACS)

2. Public Comment

There were no public comments.

3. Review of November 08, 2011 Minutes

TAC members reviewed the meeting minutes from November 08, 2011 and by consensus approved them as written with a minor change requested from Kim Huffman of AC Transit, "Kim Huffman shared that AC Transit staff is preparing a GM memo to go to the Board of Directors on November 16, 2011 seeking authorization for 4.2 percent for AC Transit ADA-mandated service (currently 4.16 percent)."

4. Discussion on the Funding Formula and Gap Policy

Richard Weiner introduced the discussion on the new proposed funding formula. He said the new funding formula is meant to address three areas of concern that impact a community's need for accessible transportation: age, disability, and income. He also stated that the formula incorporates four factors:

- Seniors aged 70 to 79
- Seniors aged 80+ (weighted times 1.5)
- Low-income household earnings equal to or less than 30 percent of the area median income (in the current proposal, this is calculated as less than \$20,000 annually)
- Disability

Richard said, ideally, the factors would align with each area of concern. Unfortunately, reliable data relating to disability has proved elusive. Therefore, staff is recommending to employ age as a proxy for disability and will continue to monitor available data sources and, if appropriate, review and revise the funding formula. He said the funding formula will take effect on July 1, 2012.

Questions and feedback from members:

- The TAC members proposed that the funding formula for a five-year period that can be revisited based on data availability. Staff obtained the age data from the most reliable source, the U.S. Census 2010, and obtained income data from the American Community Survey. This data is supplemented annually, and the sample will presumably improve over time. Therefore, staff proposes updating this income factor annually.
- A member asked when TAC members would receive the financial projections. Staff stated that draft financial projections will come out in January or February 2012, and staff will send copies to members when available.

5. Technical Exchange

A. Mobility Management

Naomi announced that Alameda CTC was awarded a federal New Freedom grant for mobility management coordination, and updating the Alameda CTC access website, which will move us closer to the one-call, one-click ability.

Shawn Fong with the City of Fremont gave an update on the South County Mobility Management Program. She also gave an update on the Tri-City Travel Training Project. The City of Fremont has been talking to East Bay Paratransit, which will open up a satellite office at Fremont City Hall. Fremont and Newark applicants will come in for Americans with Disabilities Act (ADA) paratransit certification, and trainers will do assessments to see if the applicants qualify for travel training. The City will hire part-time outreach coordinators with language capabilities other than English to assist in travel training.

B. Preparedness

- Gail Payne stated that City of Alameda has a new preparedness program in coordination with the City fire department. She will contact the fire department and update the TAC on the status.

C. Ask a TAC Member

Naomi talked about how the compliance form is working for TAC members. She stated that members have asked to be more involved on how to prepare the form for next year. Members provided this input:

- A member stated that Tamara Halbritter was very helpful in showing members how to fill out the compliance forms, and he is grateful that Alameda CTC is open to members' suggestions for next year.
- Members asked if Tamara will come to the TAC meeting to help explain how to document fares in the report. Matt Todd stated that he would ask Tamara to provide further instructions on how to document fares in the compliance report, Table 1 Attachment, and the audit report.

Members raised the following concerns about Clipper:

- David Zehnder with the City of Newark stated he is working with seniors on Clipper card registration. Shawn, City of Fremont, added that she has been having conversations with the Metropolitan Transportation Commission (MTC) and AC Transit regarding the City of Fremont becoming a Clipper card distributor for seniors (to distribute Regional Transit Connection (RTC) Clipper cards, but not process them).
- Members mentioned that the transition to the Clipper card has been frustrating, and they have not received clear answers. Naomi stated that she is working with Karen Konecky from MTC on the RTC Card issues matrix. Naomi stated that Karen would like to attend the next Countywide travel training meeting, and perhaps she could address TAC's concerns. The meeting is scheduled for February 28th at 2 p.m.

D. Other Technical Exchange Items

- A member asked about how bridge tolls factor into EBP fares: Is there an established agreement? BART staff stated that the fare includes the bridge toll and is factored into the fare based on trip distance. A member asked if people who receive East Bay Paratransit service pay the toll when they go across the bridge. BART staff said that the service providers have FasTrak, and they pay for the tolls.

8. Information Items

A. CWTP-TEP Status

Matt provided information on the regional and countywide transportation planning efforts related to the updates of the Countywide Transportation Plan and Sales Tax Transportation Expenditure Plan (CWTP-TEP) as well as the Regional Transportation Plan (RTP) and the development of the Sustainable Community Strategy (SCS). He said the Commission retreat is scheduled for Friday, December 16, 2011, from 8:30 a.m. to 2 p.m. at the Newark Pavilion, 6430 Thornton Avenue, in Newark, and all members are invited to attend. He stated that the Commission will receive updates on the regional and countywide transportation plans and on the draft Transportation Expenditure Plan.

All comments received at the meeting will be developed into a Final Draft TEP for Commission approval at its January 26, 2012 meeting.

Questions and feedback from members:

- A member asked if BART is invited to attend. Staff stated that all transit agencies, Commission members, local jurisdictions, and the public are invited.

B. SRAC Update

Kim Huffman stated that she attended the SRAC meeting, and there was a survey regarding CWTP. The next SRAC meeting is scheduled for January 3, 2012.

C. PAPCO Update

Staff said the next PAPCO meeting is scheduled for January 23, 2012 and encouraged TAC members to attend.

D. TAC Committee Member Announcements

Staff stated that Union City has approved a paratransit fare increase for next year.

E. Alameda CTC Staff Report

Staff stated that Alameda CTC has developed a new Master Programs Funding Agreement and Implementation Guidelines that the Commission will approve. The goal is to put in place the new agreements in March 2012.

F. Outreach

Krystle Pasco mentioned this upcoming outreach event:

G. Other Staff Updates

Naomi said the Joint PAPCO/TAC Subcommittee meeting is scheduled for December 5, 2011, from 11 a.m. to 2 p.m., and she invited all TAC members to attend.

The Alameda CTC is in the process of updating the Alameda County Countywide Transportation Plan (CWTP), a 20-year plan that lays out a strategy for addressing transportation needs for all users in Alameda County and feeds into the Regional Transportation Plan. The Alameda CTC is also developing a new Transportation Expenditure Plan (TEP) concurrently with the CWTP.

The following committees are involved in the CWTP-TEP development process:

Steering Committee: Comprised of 13 members from the Alameda CTC including representatives from the cities of Berkeley, Emeryville, Hayward, Livermore, Newark, Oakland, Pleasanton, and Union City, as well as Alameda County, BART and AC Transit. Mayor Mark Green of Union City is the chair and Councilmember Kriss Worthington of Berkeley is the vice-chair. The purpose of the Steering Committee is to lead the planning effort, which will shape the future of transportation throughout Alameda County. SUBJECT: **Review of Countywide Transportation Plan (CWTP) and Transportation Expenditure Plan and Update on Development of a Sustainable Community Strategy (SCS)/Regional Transportation Plan (RTP)**

Recommendation

This item is for information only. No action is requested.

Summary

This item provides information on regional and countywide transportation planning efforts related to the updates of the Countywide Transportation Plan and Sales Tax Transportation Expenditure Plan (CWTP-TEP) as well as the Regional Transportation Plan (RTP) and the development of the Sustainable Community Strategy (SCS).

Discussion

Ten separate committees receive monthly updates on the progress of the CWTP-TEP and RTP/SCS, including ACTAC, the Planning, Policy and Legislation Committee (PPLC), the Alameda CTC Board, the CWTP-TEP Steering Committee, the Citizen's Watchdog Committee, the Paratransit Advisory and Planning Committee, the Citizen's Advisory Committee, the Bicycle and Pedestrian Advisory Committee, and the Technical and Community Advisory Working Groups. The purpose of this report is to keep various Committee and Working Groups updated on regional and countywide planning activities, alert Committee members about issues and opportunities requiring input in the near term, and provide an opportunity for Committee feedback in a timely manner. CWTP-TEP Committee agendas and related documents are available on the Alameda CTC website. RTP/SCS related documents are available at www.onebayarea.org.

January 2012 Update:

This report focuses on the month of January 2012. A summary of countywide and regional planning activities for the next three months is found in Attachment A and a three year schedule for the countywide and the regional processes is found in Attachments B and C, respectively. Highlights at the regional level include release of draft Project Performance and Targets Assessment results, draft Scenario Analysis results and the beginning of the discussion about tradeoffs and investment strategies. At the county level, highlights include the release of the draft Transportation Expenditure Plan for approval by the Alameda CTC Board at its January meeting and submittal of draft CWTP projects and programs to MTC for development of the Preferred SCS and transportation network.

1) SCS/RTP

MTC released draft results of the project performance and targets assessment in November 2011 followed by the draft scenario analysis results on December 9, 2011. ABAG continued work on the One Bay Area Alternative Land Use Scenarios. Comment letters are being prepared by Alameda CTC staff and will be distributed to the committees as they are available. MTC and ABAG will use the results of the project performance and targets assessment along with the results of the scenario analysis to begin framing the discussion about tradeoffs and investment strategies that will ultimately result in the selection of a preferred land use and transportation scenario. This scenario will be evaluated February 2012 and results released in March 2012.

2) CWTP-TEP

At the December 16, 2011 Commission retreat, staff presented the Administrative Draft CWTP, revised project and program list, draft CWTP evaluation results and second draft Transportation Expenditure Plan. After receiving extensive public comment on the draft Transportation Expenditure Plan, the Commission directed staff to set up a meeting between an ad hoc committee made up of members of the CWTP-TEP Steering Committee and specific advocacy groups to discuss aspects of the expenditure plan. These meetings will be held by mid-January in order to prepare and distribute the Draft Transportation Expenditure Plan for Steering Committee review. At its January meeting, the Steering Committee is anticipated to recommend that the Commission approve the Transportation Expenditure at its meeting the same day. Once approved the Transportation Expenditure Plan will be taken to each city council and the Board of Supervisors for approval by May 2012. Both the Draft Transportation Expenditure Plan and the CWTP will be brought to the Commission in May/June 2012 for approval so that the Board of Supervisors can be requested at their July 2012 to place the Transportation Expenditure Plan on the ballot on November 6, 2012.

**Summary of Next Quarter Countywide and Regional Planning Activities
(January 2012 through March 2012)**

Countywide Planning Efforts (CWTP-TEP)

The three year CWTP-TEP schedule showing countywide and regional planning milestone schedules is found in Attachment B. Major milestone dates are presented at the end of this memo. During the January 2012 through March 2012 time period, the CWTP-TEP Committees will be focusing on:

- Coordinating with ABAG and local jurisdictions to provide comments on the Alternative Land Use Scenarios for the Sustainable Communities Strategy (SCS);
- Preparing and submitting comments to MTC on the project performance and targets assessment and scenario evaluation results;
- Coordinating with the local jurisdictions and ABAG to develop a draft Alameda County Locally Preferred SCS to test with the financially constrained transportation network in Spring 2012;
- Responding to comments on the Administrative Draft and releasing the Draft CWTP;
- Refining the financially constrained list of projects and programs for the Draft CWTP;
- Refining the countywide 28-year revenue projections consistent and concurrent with MTC's 28-year revenue projections;
- Presenting the Draft CWTP and Draft TEP to the Steering Committee and Commission for approval; and
- Seek jurisdiction approvals of the Draft TEP.

Regional Planning Efforts (RTP-SCS)

Staff continues to coordinate the CWTP-TEP with planning efforts at the regional level including the Regional Transportation Plan (MTC), the Sustainable Communities Strategy (ABAG), Climate Change Bay Plan and amendments (San Francisco Bay Conservation and Development Commission (BCDC)) and CEQA Guidelines (Bay Area Air Quality Management District (BAAQMD)).

In the three month period for which this report covers, MTC and ABAG are or will be:

- Framing the tradeoff and investment strategy discussion and developing policy initiatives for consideration;
- Refining draft 28-year revenue projections;
- Finalizing maintenance needs and Regional Programs estimates; and
- Conducting public outreach.

Staff will be coordinating with the regional agencies and providing feedback on these issues, through:

- Participating on the MTC/ABAG Regional Advisory Working Group (RAWG);
- Submitting local transportation network priorities through the CWTP-TEP process; and
- Assisting in public outreach.


