

#### 1. Welcome and Introductions

Paratransit Coordinator Naomi Armenta called the meeting to order at 1:35 p.m. The meeting began with introductions and a review of the meeting outcomes.

**Guests Present:** Betty Mulholland, Paratransit Advisory and Planning Committee (PAPCO); and Sharon Powers, PAPCO.

#### 2. Public Comment

There were no public comments.

#### 3. Review of September 13, 2011 Minutes

TAC members reviewed the meeting minutes from September 2011 and by consensus approved them as written.

#### 4. Discussion on Draft Paratransit Program Implementing Guidelines

Matt Todd introduced the discussion on the draft Paratransit Program Implementing Guidelines. He gave a brief description of the guidelines, and stated that TAC and PAPCO members discussed the implementing guidelines at their September meetings. John Hemiup stated that Alameda CTC will incorporate by reference all the comments and input on the implementing guidelines, and that the new Paratransit Master Program Funding Agreement

in development will refer to the Paratransit Program Implementing Guidelines. John mentioned that as of 2012, we will be at the midpoint of Measure B and have had 10 years of experience with a variety of paratransit programs funded by pass-through and Gap funding. The desire is to have the new agreement and guidelines in place by April 1, 2012.

Naomi informed members about the PAPCO Implementing Guidelines Subcommittee meeting scheduled for Monday, October 17, 2011 from 12 to 3 p.m., and encouraged all members to come.

John stated that the plan is to get more input from committee members and do another draft of the implementing guidelines. If members come to a consensus, staff will take the Paratransit Implementing Guidelines back to the committee and up to the Commission by the end of next month.

#### Member input and staff responses:

Members wanted to know if staff made any changes to the memo included in the
packet from the September 7, 2011 memo. Staff stated no, Alameda CTC
documented the TAC questions for PAPCO and were unable to include the PAPCO
questions in the TAC packet because of the mail out date between the PAPCO and
TAC meetings. Staff included and updated 75 percent of all members' comments in
the Implementing Guidelines.

#### **Taxi Programs**

Richard Weiner opened the discussion about the specific types of services listed in the guidelines with the Taxi Programs, and using vouchers versus reimbursement. He stated that he would like to review and talk about TAC members' comments and Alameda CTC's responses that were not discussed previously.

#### Member input and staff responses:

- The taxi service is intended to be a safety net to meet needs of eligible patrons.
- For same-day service, a member suggested expanding the availability of accessible (lift-equipped) taxi vehicles. Cities should require meters in accessible taxis and provide door-to-door services.
- Regarding eligibility, seniors 70 years or older without proof of a disability should be
  eligible, along with people 18 years old and above with disabilities who are unable to
  use fixed-route services. Members suggest using Americans with Disabilities Act
  (ADA) eligibility as established by ADA-mandated providers.
- Lift equipped/accessible vans should all have meters, and Alameda CTC should write this into the guidelines for taxi vehicles used in this program.
- One member said that taking taxis across jurisdictions and counties can be confusing.

#### **Vehicle Registration Fees**

Before continuing the discussion on the paratransit services in the implementing guidelines, members asked for more information on the Vehicle Registration Fees mentioned in the Master Program Funding Agreement.

#### Member input and staff responses:

- Members were not clear on the Vehicle Registration Fee funding. With ACTIA, it was clear how much percentage went into each program. Matt Todd reported that the vehicle registration fee will amount to about \$2.5 million per year (\$10 million dollars total) be distributed as follows:
  - o 60 percent Local Road Improvement and Repair Program
  - o 25 percent Transit for Congestion Relief
  - 10 percent Local Transportation Technology Program
  - o 5 percent Pedestrian and Bicylist Access and Safety Program
  - There are no sub categories specifically for paratransit, whether fixed-route, rail, or bus.
- Members asked if these are pass-through programs. Matt explained that the mass transit and the local technology programs are discretionary programs, similar to a grant program. The others are pass-through fund programs.
- Members asked if the 25 percent for mass transit is an allocation to specific agencies. Staff said that the discretionary funds come through your city, and the distributions are based on population and the number of registered vehicles.
- Members asked if they can apply for VRF funding. Matt explained that they can apply for additional VRF funding, but there is no guarantee that they will get it. Naomi explained that if we get other funds, the guidelines will still apply to the funding. Matt said if you compete for those funds, you cannot win if you do not have the master programs funding agreement, but the master agreement will reflect all fund sources.
- The advocacy behind this Measure was money for transit. Matt stated that you should not expect any extra money in your annual operating budget from VRF.
   Counties will have stiff competition for that \$2.5 million.
- A member wanted to know if the Measure B grant formula for the base program will stay the same for next 10 years. Staff explained that the current funding formula is expiring on June 30, 2012 and needs to be revisited.
- A member asked if Oakland will still get its Measure B allocation based on the Measure B formula if the measure goes back to voters. Staff stated that the Measure B funding is listed in the Expenditure Plan and was approved by the Board and PAPCO helps define it. Staff stated that Alameda CTC is not bringing the funding formulas to the table at the November 8<sup>th</sup> 2011 meeting. The current Expenditure Plan stays as it is through 2012.
- A member thinks that the funding formula is more important than the Gap Policy.
   Naomi stated that the Gap Policy is closer to being done and staff will bring it to the table for discussion at the November meeting.

#### City Fixed-route Shuttles and City-based Door-to-Door Services

Staff comments and member input:

- Parts of the county have three to four different same-day service options that are similar but not on the same level as the ADA.
- A member said that lowering the age for this type of service would increase costs. Also, for people in the age range of 70 to 79, some may prefer to take the door-to-door service instead of the fixed-route service; although, we would want them to continue to take the fixed-route service. Shifting the costs away from the door-to-door programs based on the parameters would shift to the ADA program, which would mean a higher cost to the ADA program (East Bay Paratransit). Instead of age eligibility for door-to-door programs, we can use ADA eligibility to use the service.
- Is it possible to provide options and to cater our services to different niche populations or to give riders the flexibility to choose all of the options?
- What are the possibilities of working beyond the service scope? How can we address
  everyone or at least not isolate some people? Staff said that some individuals are
  isolated as AC Transit continues to diminish bus lines, further decreasing East Bay
  Paratransit's coverage area. These individuals may start to rely on more door-todoor services or taxi programs.
- Members are concerned about how policies will affect these new guidelines.
   Consumers may not choose to go to East Bay Paratransit first, but the city-based programs are designed to be supplemental to East Bay Paratransit. Staff responded that discretion for verifying eligibility will still be up to the program managers, as each program has different criteria for eligibility.
- Who will have the discretion for determining fares for these different types of services? Staff said the local jurisdictions may determine these fares since each service is flexible.

#### **Group Trips**

Members did not provide input on this service.

#### **Volunteer Driver Programs**

Member input and staff comments:

- A member said that this is the highest premium service.
- Another member asked with regard to the funding coming from pass-through funding, do we have to use those funds to supplement our volunteer driver programs? There is no more funding coming from the general fund so we are using our pass-through funds. It is becoming more difficult for us to provide a wide array of services as Alameda CTC continues to define gap funding.

#### **Mobility Management and Travel Training**

Members did not provide input on this service.

#### **Meal Service Delivery**

Member input:

• This should be further defined to describe the subsidy or what the options look like. The description should include maximum subsidies, equitability, cost per meal, etc.

#### Scholarship/Subsidized Fare Program

• Purchasing large quantities of East Bay Paratransit tickets for resale may no longer be allowed under the new guidelines.

# Countywide Transportation Plan Update and Transportation Expenditure Plan Development Overview

The Alameda CTC is in the process of updating the Alameda County Countywide Transportation Plan (CWTP), a 25-year plan that lays out a strategy for addressing transportation needs for all users in Alameda County and feeds into the Regional Transportation Plan. The Alameda CTC is also developing a new Transportation Expenditure Plan (TEP) concurrently with the CWTP.

The following committees are involved in the CWTP-TEP development process:

**Steering Committee:** Comprised of 13 members from the Alameda CTC including representatives from the cities of Berkeley, Emeryville, Hayward, Livermore, Newark, Oakland, Pleasanton, and Union City, as well as Alameda County, BART and AC Transit. Mayor Mark Green of Union City is the chair and Councilmember Kriss Worthington of Berkeley is the vice-chair. The purpose of the Steering Committee is to lead the planning effort, which will shape the future of transportation throughout Alameda County. Community Advisory Working Group (CAWG): Comprised of 27 members representing diverse interests throughout Alameda County including business, civil rights, education, the environment, faith-based advocacy, health, public transit, seniors and people with disabilities, and social justice. #### Recommendation

This item is for information only. No action is requested.

#### **Summary**

This item provides information on regional and countywide transportation planning efforts related to the updates of the Countywide Transportation Plan and Sales Tax Transportation Expenditure Plan (CWTP-TEP) as well as the Regional Transportation Plan (RTP) and the development of the Sustainable Community Strategy (SCS).

#### **Discussion**

ACTAC; the Planning, Policy and Legislation Committee (PPLC); the Alameda CTC Board; the Citizen's Watchdog Committee; the Paratransit Advisory and Planning Committee; the Citizen's Advisory Committee; and the Bicycle and Pedestrian Advisory Committee receive monthly updates on the CWTP-TEP and RTP/SCS. The purpose of this report is to keep various Committee and Working Groups updated on regional and countywide planning activities, alert Committee members about issues and opportunities requiring input in the near term, and provide an opportunity for Committee feedback in a timely manner. CWTP-TEP Committee agendas and related documents are available on the Alameda CTC website. RTP/SCS related documents are available at www.onebayarea.org.

#### July 2011 Update:

This report focuses on the month of July 2011. A summary of countywide and regional planning activities for the next three months is found in Attachment A and a three year schedule for the countywide and the regional processes is found in Attachment B and Attachment C respectively. Highlights include MTC and ABAG's alternative scenario and performance assessment and the release of Alameda CTC's first round evaluation results of the transportation investment packages.

1) MTC/ABAG Development of Alternative Land Use and Transportation Scenarios

MTC and ABAG have released draft alternative land use and transportation scenarios, which were presented to the MTC Planning and ABAG Administration Committees and the MTC Commission at

their June 10 and June 22 meetings. The MTC Commission and ABAG Administrative Committee after much discussion and public comment approved five land use options and two transportation options and directed staff to bring back additional information on how social equity will be accomplished in the analysis. MTC staff will begin its performance assessment with result anticipated to be released in October.

#### 2) RTP/SCS Work Element Proposals

MTC continues to refine their proposals and guidance for the following work elements of the RTP/SCS including:

- Releasing draft 25-year revenue projections (county budgets are not anticipated to be available until Fall 2011); and
- Developing draft transit capital, local streets and roads maintenance needs, and transit operation needs estimates.

# Summary of Next Quarter Countywide and Regional Planning Activities (October 2011 through January 2012)

#### Countywide Planning Efforts (CWTP-TEP)

The three year CWTP-TEP schedule showing countywide and regional planning milestone schedules is found in Attachment B. Major milestone dates are presented at the end of this memo. During the October 2011 through January 2012 time period, the CWTP-TEP Committees will be focusing on:

- Coordinating with ABAG and local jurisdictions to provide comments on the Alternative Land Use Scenarios for the Sustainable Communities Strategy (SCS);
- Coordinating with the local jurisdictions to develop a draft Alameda County Locally Preferred SCS to test with the financially constrained transportation network in October;
- Responding to comments on the Administrative Draft CWTP;
- Refining the financially constrained list of projects and programs for the Draft CWTP;
- Developing the second draft CWTP;
- Refining the countywide 25-year revenue projections consistent and concurrent with MTC's 25-year revenue projections;
- Developing first draft Transportation Expenditure Plan (TEP) list of projects and programs;
- Conducting public outreach and a second poll; and
- Presenting the Draft CWTP and Draft TEP to the Steering Committee and Commission for approval.

#### Regional Planning Efforts (RTP-SCS)

Staff continues to coordinate the CWTP-TEP with planning efforts at the regional level including the Regional Transportation Plan (MTC), the Sustainable Communities Strategy (ABAG), Climate Change Bay Plan and amendments (San Francisco Bay Conservation and Development Commission (BCDC)) and CEQA Guidelines (Bay Area Air Quality Management District (BAAQMD)).

In the three month period for which this report covers, MTC and ABAG are focusing on

- Conducting a scenario analysis of five land use options and two transportation network (Alameda CTC staff is providing input into both of these activities);
- Releasing the results of the scenario analysis and project performance assessment;
- Refining draft 25-year revenue projections;
- Finalizing maintenance needs and Regional Programs estimates; and
- Adopting a RHNA Methodology.

Staff will be coordinating with the regional agencies and providing feedback on these issues, through:

- Participating on the MTC/ABAG Regional Advisory Working Group (RAWG),
- Participating on regional Sub-committees (Equity sub-committee);
- Developing a written response to the Alternative Land Use Scenarios;
- Developing local transportation network priorities through the CWTP-TEP process; and
- Assisting in public outreach.




