2010 MERGER:

Two Countywide Transportation Agencies Become One



- First authorized by voters in 1986
- Reauthorized in 2000 by 81.5% of voters
- Half-cent sales tax for transportation in Alameda County
- Generates roughly \$100M per year
- One of the first Self-Help Counties in state
- Funds countywide projects, programs, and local operations maintenance and services
- Created in 1991 by a joint-powers agreement between Alameda County and all its cities
- Prop 111 (1990) requires urban counties to designate a Congestion Management Agency
- Prop 111 added \$.09/gallon to the state fuel tax
- Funds local, regional and state transportation projects and services

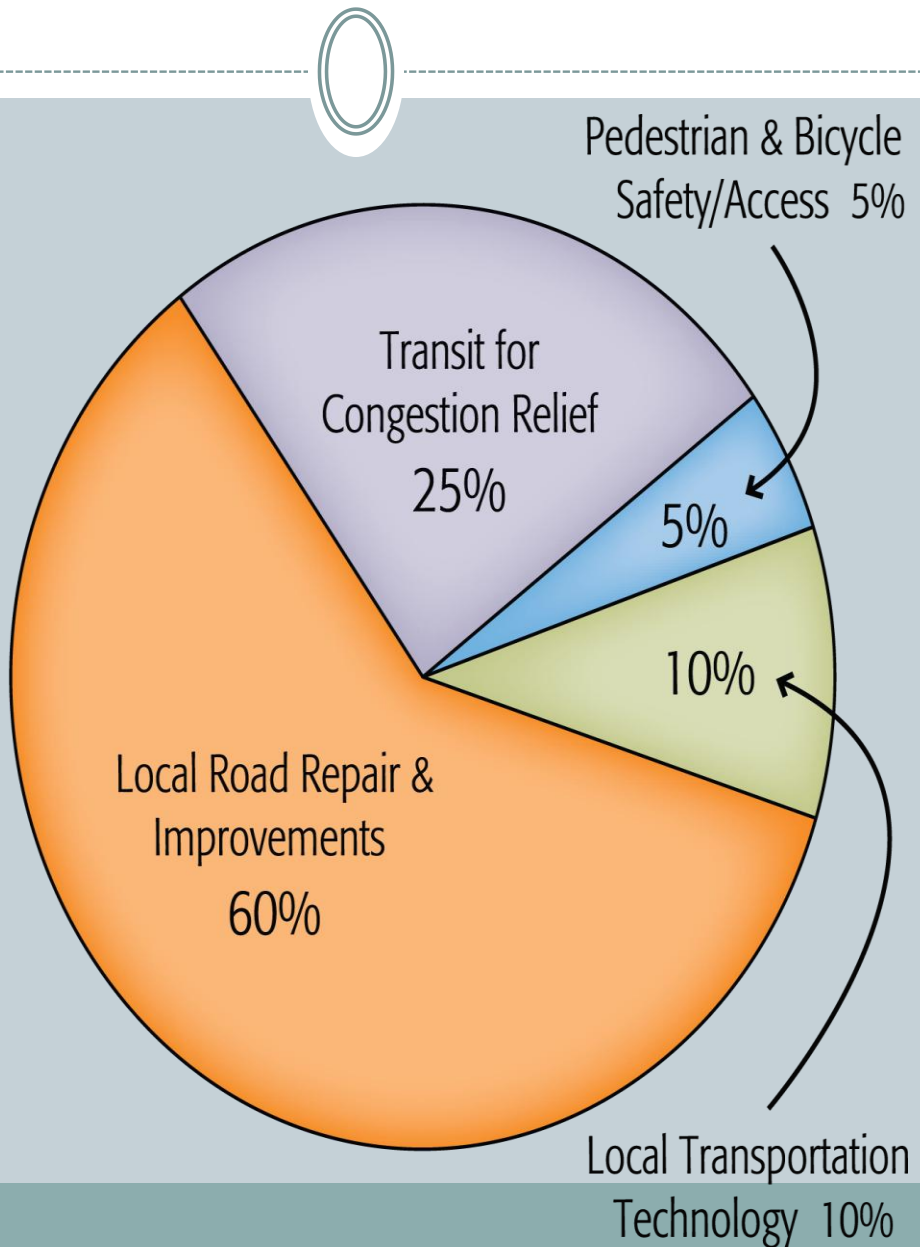

Key Transportation Funding Considerations in Alameda County

- **Volatility and Declines in Funding** = Challenges for adequately delivering multi-modal solutions
- **Legislative mandates:**
 - **AB 32:** Global Warming Solutions Act – reduce greenhouse gas emissions to 1990 levels by 2020
 - **SB375:** Transportation planning, sustainable communities strategy, environmental review to reduce greenhouse gas emissions
- **Building upon successes of current Measure, plan for new projects**
- **Address declines revenues and funding opportunities as needs increase**

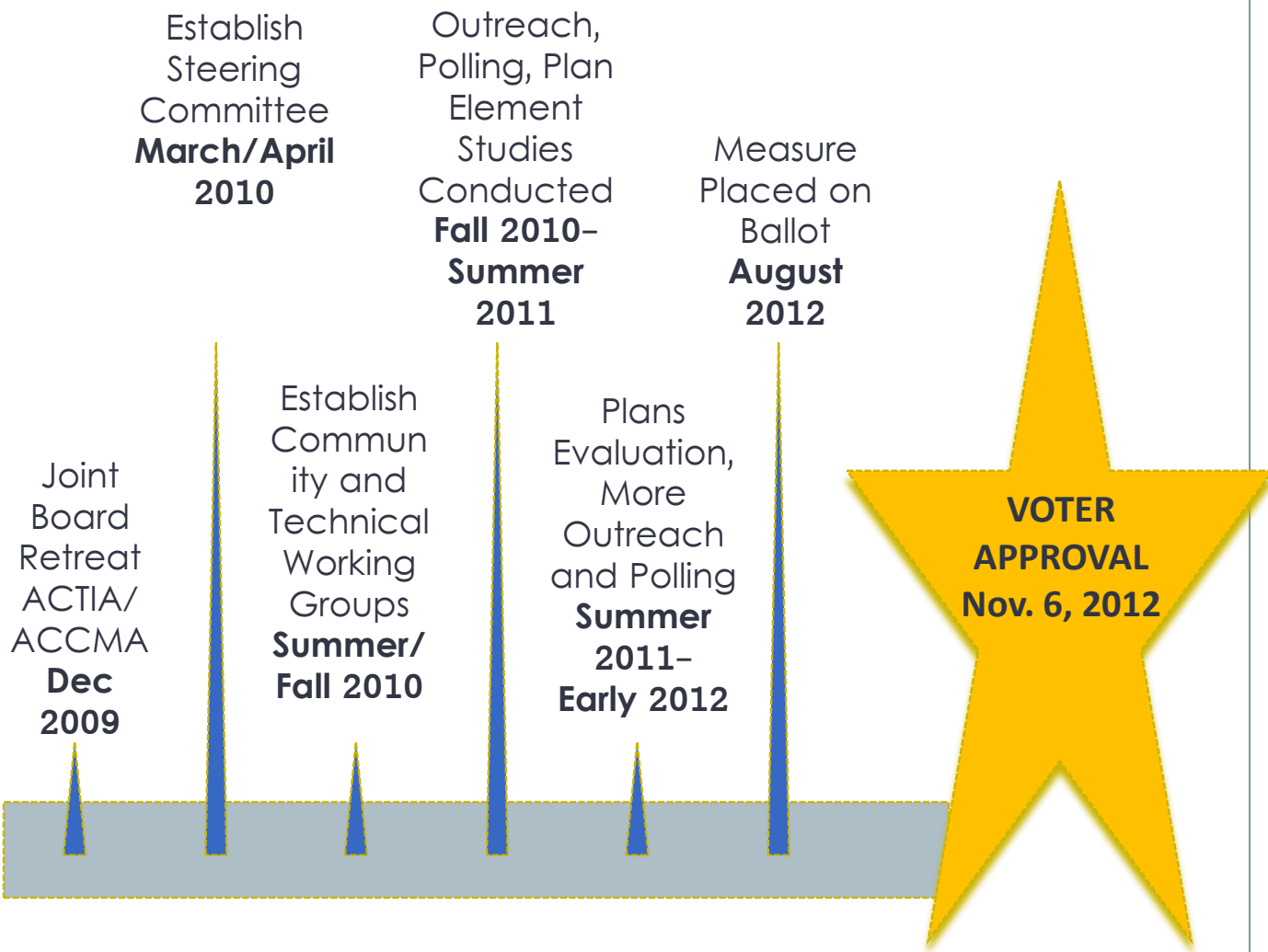
Expenditure Plan



- **\$11 million per year**
- **Benefits those who pay it**
- **Approval will require a 50% vote**
- **November 2, 2010 Ballot**
- Transportation-related programs that have a relationship and benefit to the persons paying the fee and are consistent with a Regional Transportation Plan.
 - Local Road Improvement and Repair Program (60%)
 - Transit for Congestion Relief Program (25%)
 - Local Transportation Technology Program (10%)
 - Pedestrian and Bicyclist Access and Safety Program (5%)
