#### **PROJECT SPONSOR** Alameda CTC

#### **PROJECT DESCRIPTION**

The East Bay Greenway Project from Coliseum BART to 85th Avenue, is a half -mile segment of a planned 15-mile bicycle and pedestrian facility that will travel through Oakland, San Leandro, Hayward and unincorporated Alameda County. The alignment generally runs under the BART tracks and the Greenway will ultimately connect five BART stations. The project is designed to improve critical pedestrian and bicycle access to intermodal transit hubs, ultimately providing a safe, accessible pedestrian and bicycle trail to encourage alternative modes of transportation. A federal stimulus TIGER II grant has been obtained to build this segment; which is the portion between Coliseum BART and 85th Avenue in Oakland.

#### **PROJECT STATUS**


Alameda CTC has used discretionary bicycle/pedestrian Measure B funds for preliminary engineering and environmental (CEQA) analysis of the 15-mile project. The Final Environmental Document (IS/MND) was adopted by the Alameda CTC Commission at their October 25, 2012 meeting.

Construction of this segment, a half mile Class 1 Bike Lane facility, is funded with a combination of \$1.7 million in federal Tiger II funds and an East Bay Regional Park District (EBRPD) WW bond match.

Construction began summer 2013 on the initial half-mile segment of the greenway. A trail dedication ceremony was held November 6, 2015 to celebrate completion of the project.
