Workshop Overview

- **Hot Topics in Mobility for Seniors and People with Disabilities**

Bonnie Nelson of Nelson\Nygaard will assess the current state of senior and accessible transportation in Alameda County and the Bay Area, illustrating how our programs have grown and evolved, adapting to new mobility options and paradigms. She'll cover topics such as Berkeley's research on new payment options for taxis, updates on California accessible parking policy, and the expansion of Clipper.

- **Transportation Access to Healthcare and Social Services**

What are some of the urgent transportation needs faced by seniors and people with disabilities in accessing healthcare? Why are some healthcare facilities located in inaccessible areas? Do we know how the Affordable Care Act will affect transportation access to medical services? Can new technologies — both in transportation and in health — improve access to healthcare? Come hear industry experts.

- **Transportation Network Companies (TNCs) and Accessibility**

In the last few years, there has been an explosion of companies that use an online and/or smart phone platform to match drivers with riders and facilitate payment for the ride. In 2013, the California Public Utilities Commission classified these companies as Transportation Network Companies or "TNCs." Come hear a facilitated panel discussion about how these new services have impacted mobility for seniors and people with disabilities and what changes may be coming in the near future. Panelists include the Disability Rights Education and Defense Fund (DREDF), the San Francisco Municipal Transportation Authority (SFMTA), Lyft, and Lift Hero.

- **New 211 Website Demonstration**

Transportation resources are now just One Call or One Click away! Over the last year, AC Transit and Eden I&R, the county's 211 operator, have compiled a comprehensive inventory of transportation resources for seniors, people with disabilities, and people on limited incomes in Alameda and Contra Costa Counties. The database can be easily accessed through a Transportation Resource Finder on the County's 211 website. 211 phone operators can also access this information, creating a one-call/one-click integrated resource to find important transportation and social services.
