

## I-580 EXPRESS LANE POLICY ADVISORY COMMITTEE MINUTES OF OCTOBER 10, 2011

## 1.0 PLEDGE OF ALLEGIANCE

## 2.0 ROLL CALL

All present with the exception of Mayor Sbranti; his alternate Don Biddle attended in his absence. Dao confirmed the quorum.

## 3.0 PUBLIC COMMENT

No public comments.

## 4.0 CONSENT CALENDAR

**4.1 Minutes of September 12, 2011 -** The committee approved the Minutes of September 12, 2011; the motion was moved by Mayor Green, seconded by Mayor Kamena and passed unanimously.

## 5.0 ADMINISTRATIVE MATTERS

No reports this month.

## 6.0 HOV/EXPRESS LANE PROJECT STATUS UPDATES

6.1 I-580 EB HOV Lane Project Status Report - Akkawi presented the status report for all activities through September 30, 2011 for the Eastbound HOV lane - Segments 1 and 2, and the HOT lane projects. Caltrans completed the project; it was accepted on September 30, 2011. Contract closeout is underway. Haggerty asked about the amount of HOT lane prep work which was done during the project. Akkawi responded that the prep work that was completed was the extra 8 foot buffer and partial conduit; conduit for a single HOT lane was laid during construction of the eastbound HOV lane. The eastbound express lane was assumed to be a single HOT lane and has since been changed to provide a double HOT lane; the addition of another HOT lane changes the design standards, the location of the gantry and overhead sign locations, and in effect will change the location of the conduit; requiring adjustment of the conduit. The committee has requested that this information be brought back with graphics to further explain conduit prep work and how it will be developed to tie into new design standards for double eastbound HOT lane.

Haggerty inquired on the status of the highway sign which was intended to inform the public of the future conversion of the new eastbound HOV lanes to express lanes. He had wanted it placed when the eastbound HOV lane opened. The sign is complete and it will be placed as soon as possible.

6.2 I-580 WB HOV Lane Project Status Report – Akkawi presented the status report for all activities through September 30, 2011 for the I-580 Westbound HOV Lane Project. 100% design PS&E for west segment is being reviewed by Caltrans staff in anticipation of the package being sent to the district office engineer. The 100% PS&E for the east segment will be submitted to Caltrans this month.

Biddle asked if ROW will potentially delay the westbound HOV schedule. Akkawi responded that if ROW condemnation is required it could be a risk however it is believed to be unlikely; construction start is scheduled for summer 2012.

**6.3 I-580 EB Express Lane Project Delivery Plan Update** – Akkawi gave a power point presentation of the project delivery plan for the I-580 Eastbound Express Lane Project and highlighted key milestones to project delivery. The power point is available on the agency website.

Haggerty inquired about day-time construction vs. night work. Akkawi and Dao explained that most of the work will be done in the day and the final pavement lift will be placed during the night. Committee members believe that options for night work should be explored in anticipation of significant congestion and traffic delays due to construction in the corridor.

**I-580 WB Express Lane Project Delivery Plan Update -** Akkawi gave a power point presentation of the project delivery plan for the I-580 Westbound Express Lane Project and highlighted key milestones to project delivery. The power point is available on the agency website.

Dao added that this time next year construction will be starting for both the Eastbound AUX/HOT and Westbound HOV and HOT Lane Projects. Alameda CTC is working diligently with project partners to ensure fastest and most cost effective delivery. Again, night work possibilities will be explored to mitigate loss of "private sector" productivity due to anticipated longer commute times.

## 7.0 STAFF REPORTS

Questions from Bob Vinn (City of Livermore):

Is MTC going to be the operator of both eastbound and westbound express lanes? Are there agreements to ensure that money made in the corridor will stay in the corridor? MTC can only become the operator if the JPA Board approves it as such and upon recommendation from Alameda CTC; one of the specific requirements being that all revenue generated in the I-580 corridor stay within the corridor.

Have we looked at the impact of the width of the second westbound HOT lane on the BART to Livermore right-of-way? In the future Alameda CTC may look at the option of seeking a design exception for the second HOT lane and potentially avoid having to widen the freeway further.
