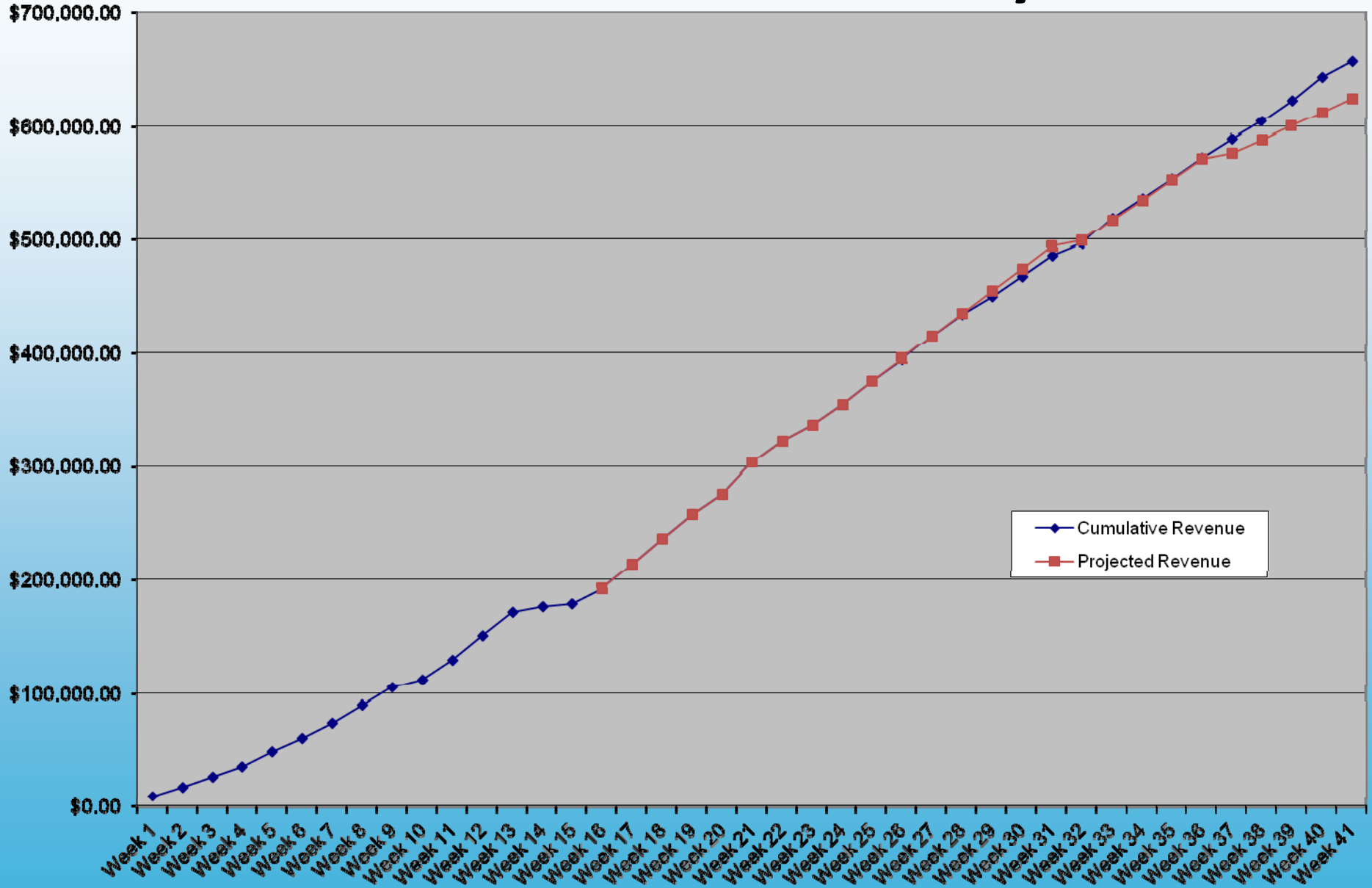


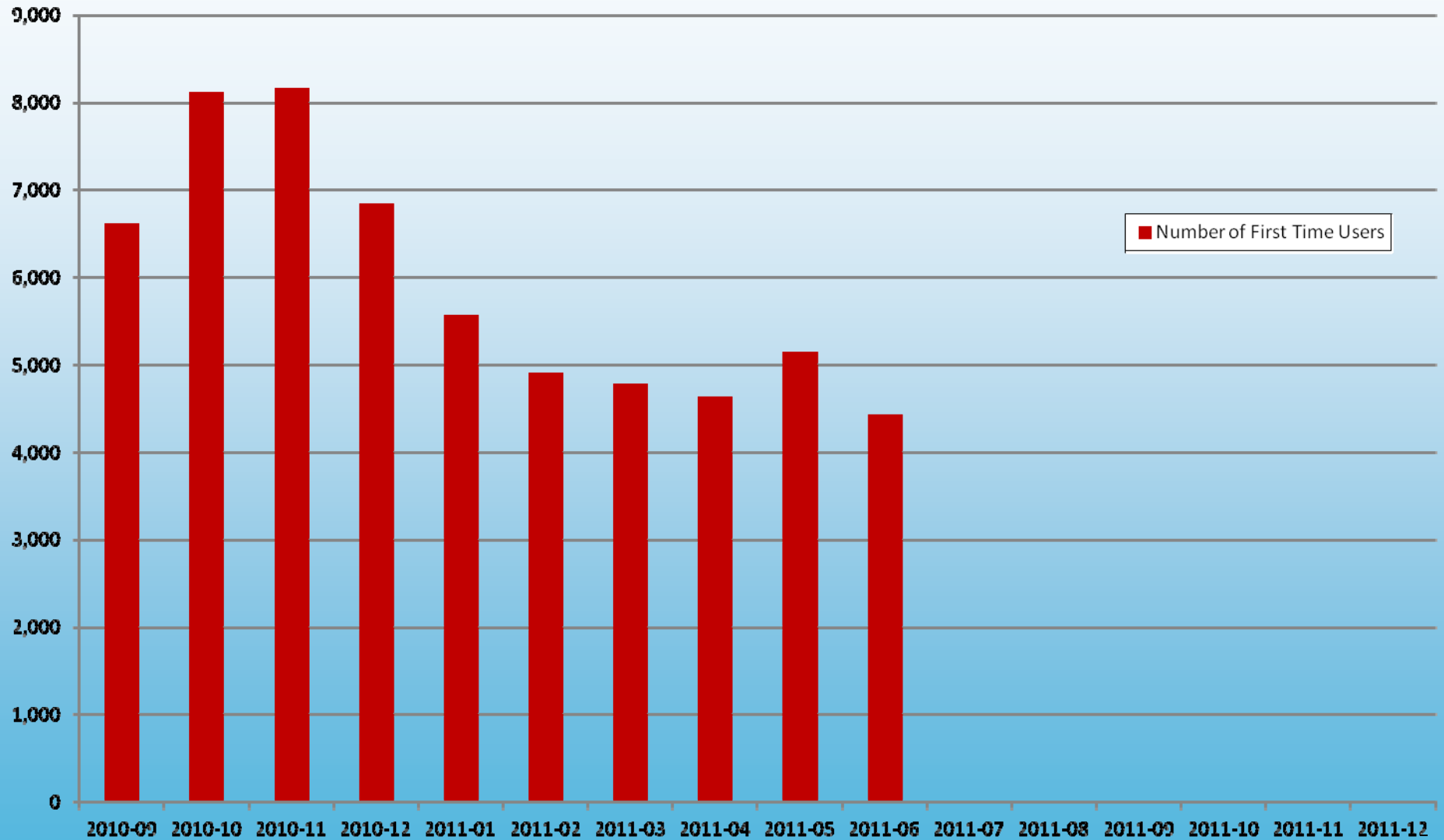

Cumulative Gross Revenue by Week

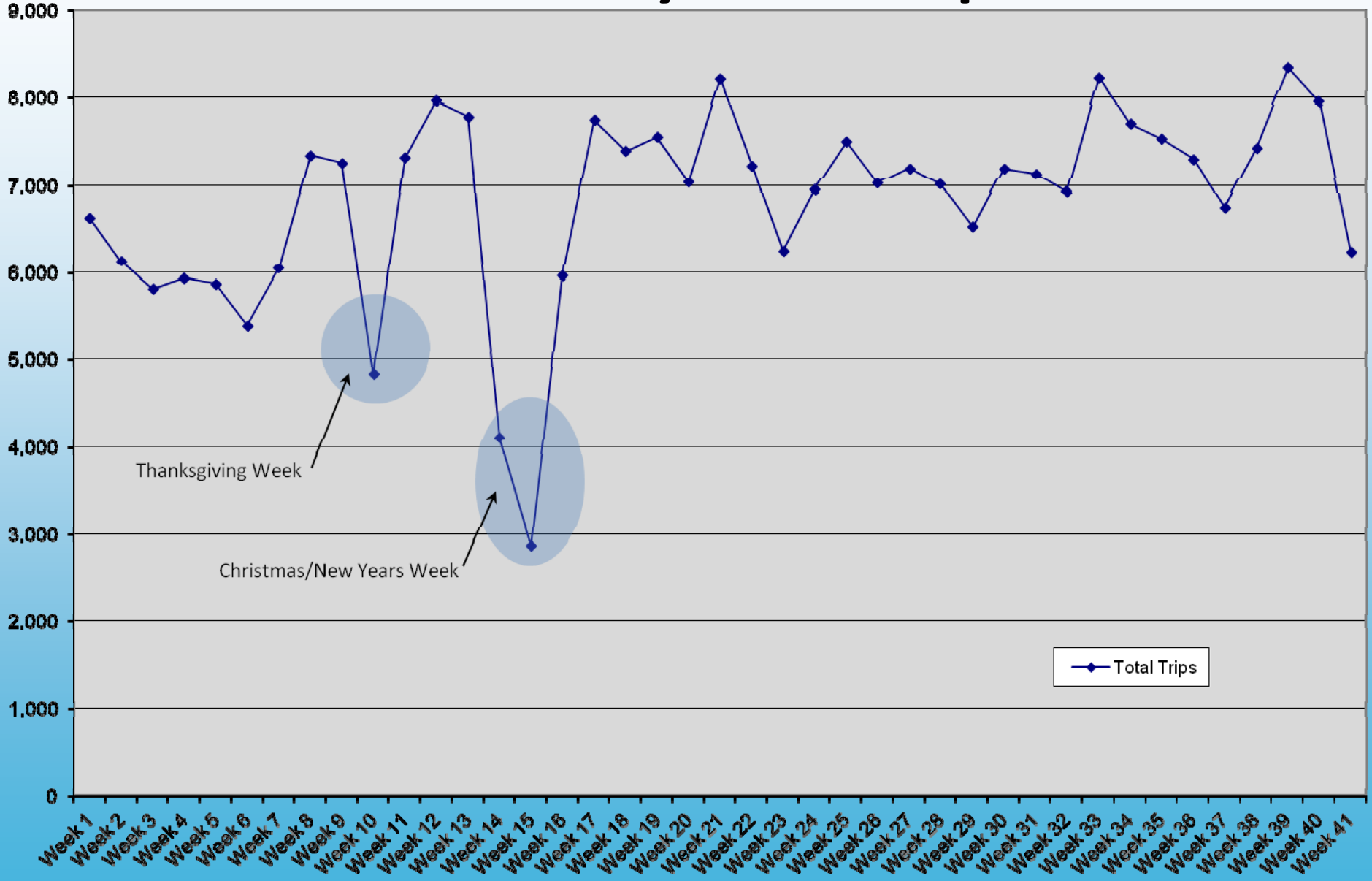


First Time Users of Express Lane

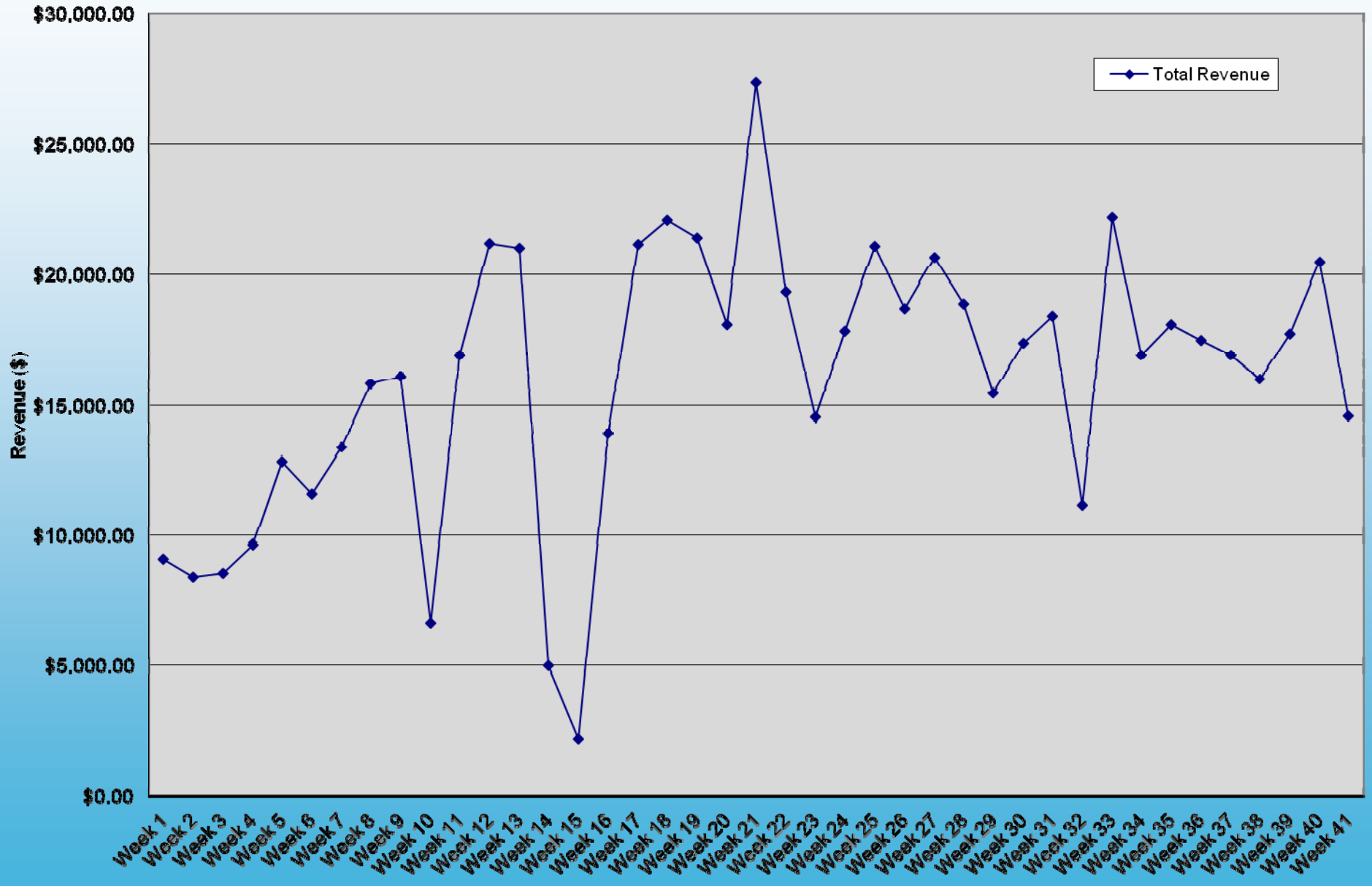

Weekly Gross Trips



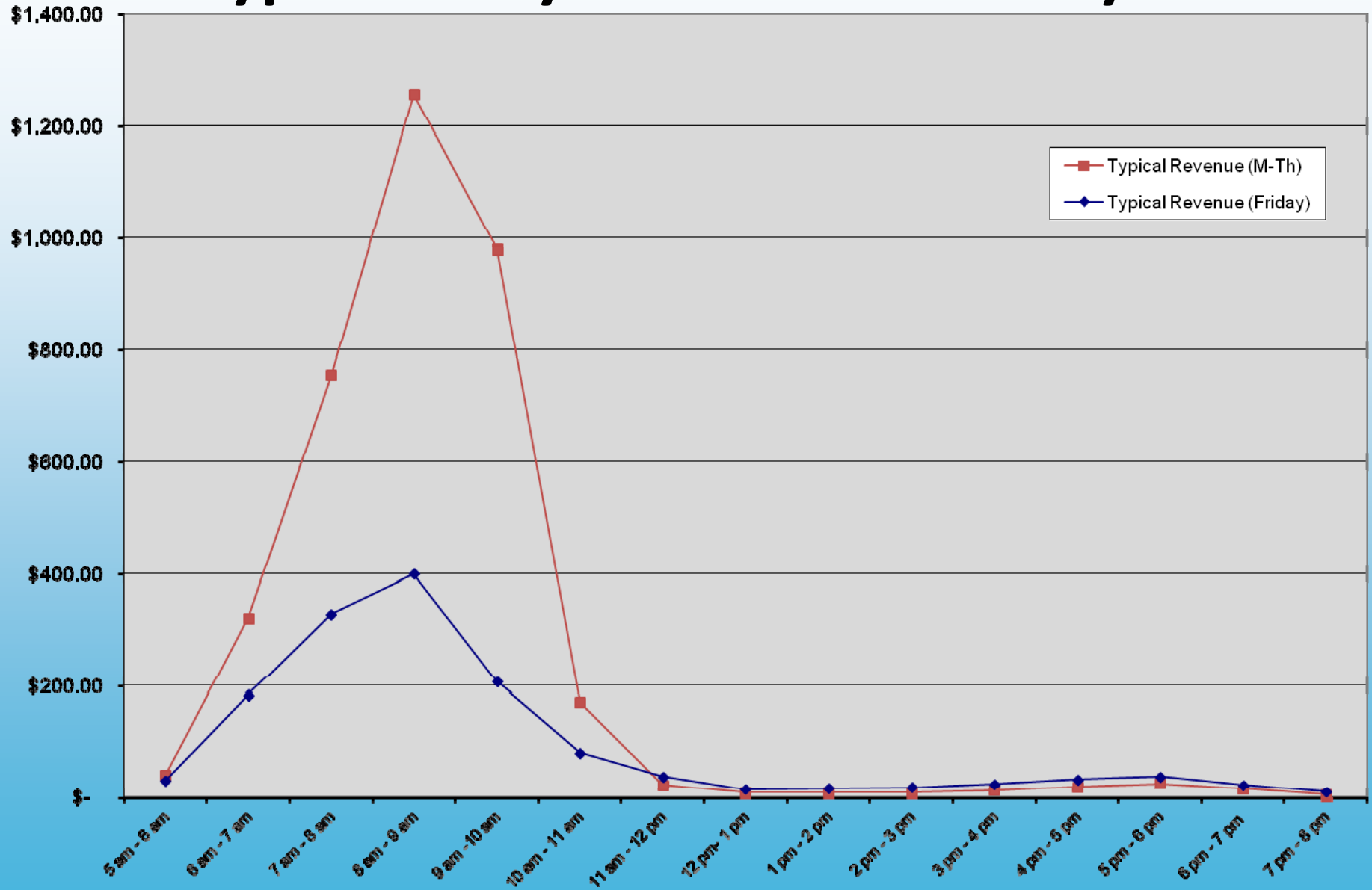
Weekly Gross Revenue



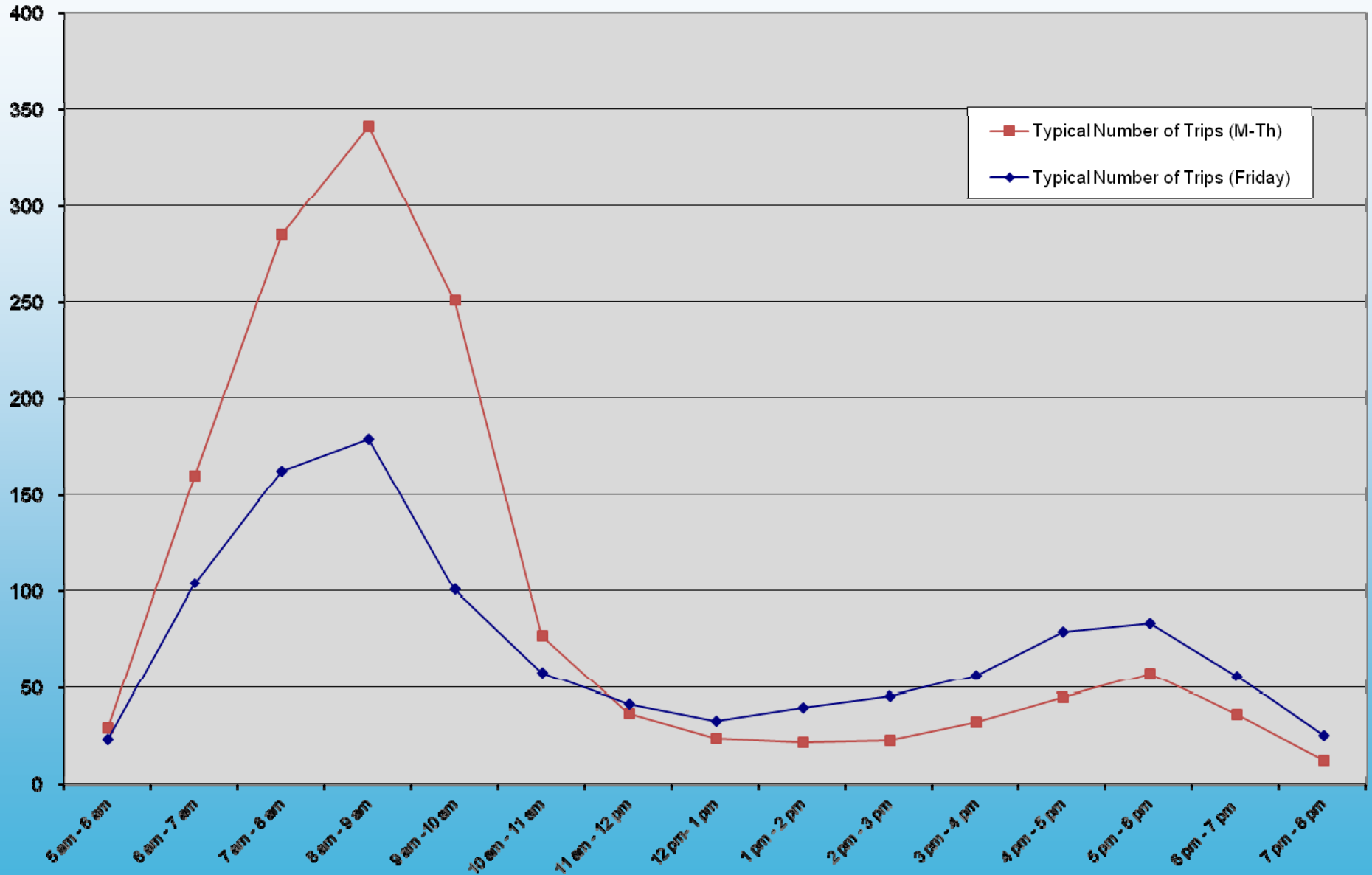
Peak Period Averages – Week 41

- 78% of Trips in AM Peak

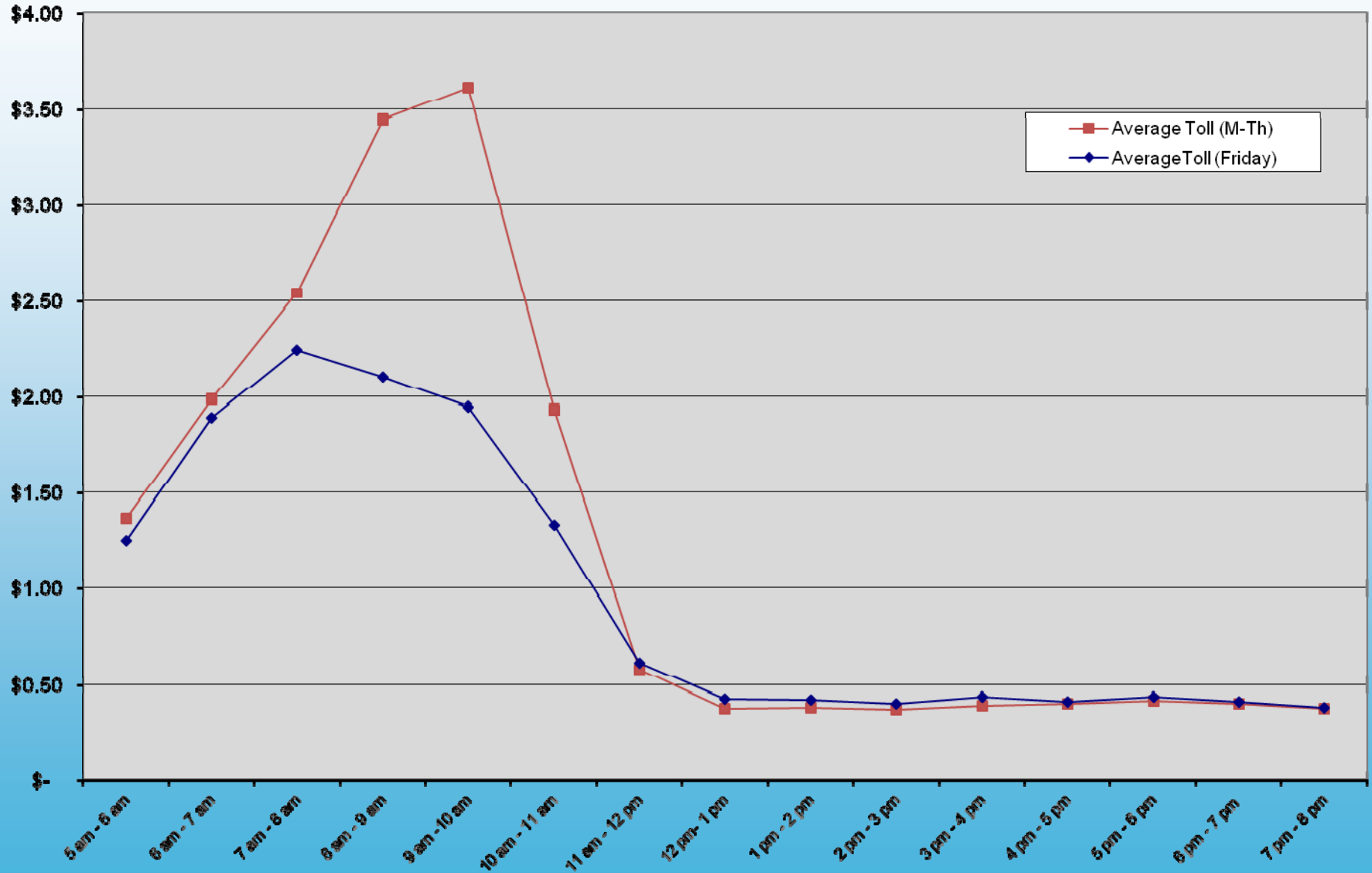
Typical Daily Revenue Totals by Hour

Improper Tag Mounting

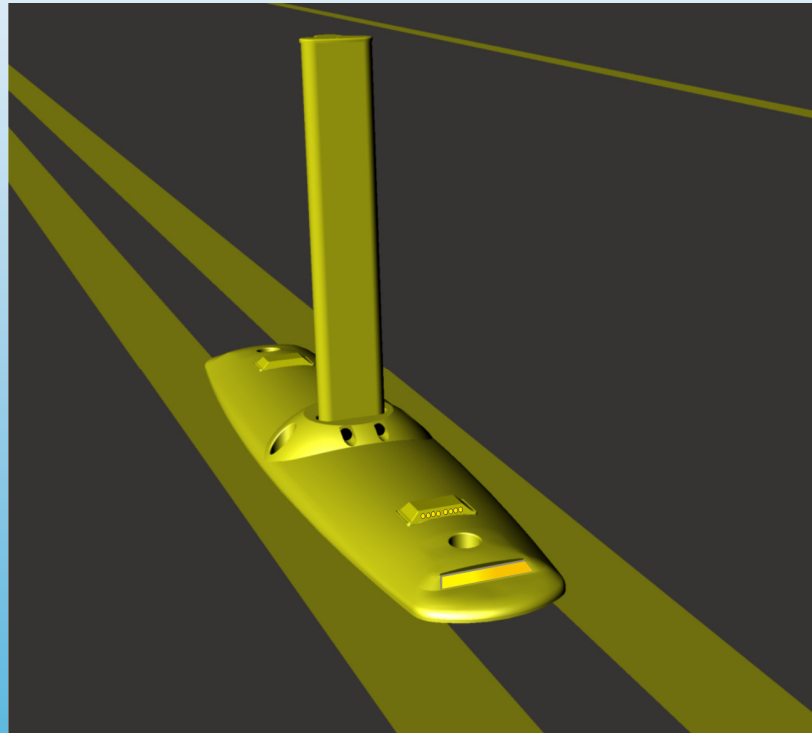
Tag must be properly mounted on the windshield by the rearview mirror to ensure the tag is read by the antenna/readers on the SB I-680 Express Lane.

CHP issuing more warning for improperly mounted tags.

Buffer Zone Delineators: The SR 91 Experience

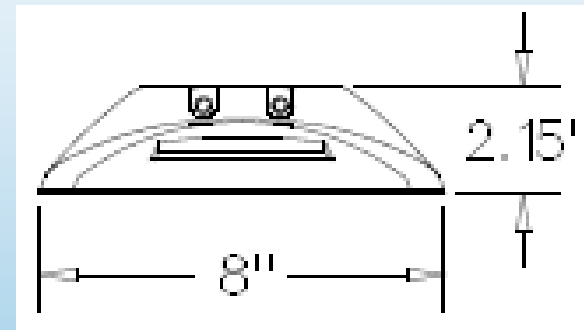
- Approx 10,000 delineators installed on 20 miles of facility.
- Delineators more durable – Not damaged at speeds under 20 MPH
- Most delineator damage due to accidents
- Replace approx 1% of delineators per month
- Most vehicles won't try to cross delineators at higher speeds
- SR 91 Violation Rate approx 3%

Turnpike Grade Curb System



Stable Platform for High Speed Installations

- Domed low-profile design for low-impact roll over
- 10 degree rise from the front edge to the highest point
- Smooth transition from road surface – no hard lines
- Designed to eliminate any form of vaulting of a vehicle
- Allows for easy transition of safety vehicles, no removal needed



White Paper on Enforcement

- Survey of what other facilities across the country are doing
- Evaluation of technologies being used
- Timing for implementation of Switchable tags
- Document will be used for consensus building with partners – CHP, Caltrans, MTC – prior to implementation

- Clarifies statute relative to white/yellow solid striping
- Makes state law consistent with federal law
