Executive Director's Message



Last month, Alameda CTC Chair, Union City Mayor Mark Green, Vice-Chair, Supervisor Haggerty and Programs and Public Affairs Manager, Tess Lengyel and I traveled to Washington, D.C. to build support for Alameda CTC's 2011 Legislative Program. I am pleased to report the trip was a success.

Back in Alameda County, voters are showing positive support for continuing the half-cent sales tax. Of the 813 Alameda County voters surveyed in a recent telephone poll:

- 72 percent are in favor of extending the half-cent transportation sales tax to address an updated plan for the county's current and future transportation needs.
- 54 percent support making the existing sales tax permanent.

Transportation Planning Updates

The Countywide Transportation Plan and Transportation Expenditure Plan development has been the focus of Alameda CTC's transportation planning efforts. The Commission is implementing a Call for Projects and Programs, and local jurisdictions and the public have identified projects and programs for consideration in both the countywide and the regional transportation plans. Alameda CTC is assisting in locating sponsors for new projects and programs, and will submit a draft list of projects and programs to MTC on April 29. The Alameda CTC advisory committees and working groups will review the draft list in May, and a public hearing and approval of the list by the Commission is scheduled for May 26. Through the CWTP-TEP committees, Alameda CTC is also seeking input on the

Project Updates.

Environmental studies for I-580 eastbound High Occupancy Vehicle (HOV) lane conversion to an express lane facility and I-580 eastbound auxiliary lanes construction between Isabel Avenue and First Street are underway. Environmental studies and the Plans, Specifications and Estimates (PS&E) are being updated for the I-580 eastbound High Occupancy Toll (HOT) and auxiliary lane projects that were combined into one construction project.

Appraisals for the right of way required for the I-580 westbound HOV lane project have been prepared and are under review by Caltrans. Commission staff is reviewing proposals to prepare a Project Study Report for the conversion of the planned westbound HOV to an express lane. The southbound HOV lane extension from Hegenberger Road to Marina Boulevard is in the final design stage; construction will begin in 2012 under two contracts. Initial Vision Scenario that will ultimately result in the Sustainable Communities Strategy (SCS). In Alameda County, we are already implementing development patterns that support the SCS and its goals to reduce drive-alone trips, promote transit and reduce greenhouse gas emissions and other pollutants. Next steps include determining what resources and infrastructure are needed to support intensified land uses identified in the Initial Vision Scenario, and where to find additional funding.

The I-880 North Safety and Operational Improvement Project, in the vicinity of 23rd Avenue and 29th Avenue in Oakland, includes replacing the 23rd and 29th overcrossings and improvements to on and off ramps. The project design is underway; the 35 percent-level PS&E were submitted in February 2011 and the Bridge Type Selection was made in March 2011. Construction will begin in fall 2012.

The Stage 1 (Subway) construction contract for the BART Warm Springs Extension is underway. BART is conducting the procurement process for the Stage 2 (LTSS) contract and expects to issue a notice to proceed by year-end 2011. BART awarded the construction contract for the BART Oakland Airport Connector in 2010. Construction activities were recently initiated and are expected to ramp up this spring.

Executive Director's Message (cont'd)

Alameda CTC will conduct another poll in fall 2011. Regarding the Countywide Transportation Plan (CWTP) and Transportation Expenditure Plan (TEP) development, we recently hosted five public workshops throughout Alameda County and received valuable input on transportation project and program priorities. At four additional workshops, the Initial Vision Scenario (IVS), developed by the Association of Bay Area Governments and the Metropolitan Transportation Commission (MTC), that will ultimately be modified into a Sustainable Communities Strategy (SCS), was presented and feedback was requested from elected officials on how Alameda County should develop in the next 25 years.

Alameda CTC is also implementing a Call for Projects and Programs that will serve the development of the CWTP and TEP as well as the Regional Transportation Plan. We will submit a draft list to MTC in April, prepare a final list for review by advisory committees and working groups in May, conduct a public hearing on May 26 and provide a final list to MTC at the end of May. In support of the I-580 Westbound Express Lane Project, Alameda CTC recently released a request for proposals to prepare a Project Study Report (see "Other News," for more information).

Other progress includes:

- Updates to the <u>Alameda Countywide Bicycle</u> and <u>Pedestrian Plans</u> that will fold into the Countywide Transportation Plan.
- Facilitating the development and operation of express lanes in the I-680 and I-580 corridors, as well as high-occupancy vehicle lanes on I-880.
- Development of the draft Vehicle Registration Fee Program strategic plan and guidelines.
- Preparations for the East County Transportation Forum on April 21, 2011, at Dublin City Hall.
- Continuing merger activities including consolidating financial accounting systems, fiscal year 2011-2012 budgets, cost allocation plans, the CalPERS retirement system, payroll and accounts payable processing.

This is a busy time of year for Alameda CTC, and I will do my best to keep you informed. As always, I welcome your questions, comments and feedback.

Programming Updates

Caldecott Tunnel Fourth Bore Project: This project continues to move forward. The construction of the pipe canopy that will support the earth above the tunnel during the first 180 feet of excavation is complete, which means that tunneling from the west can begin. As this work begins, progress will continue on the tunnel's eastern side.


The tunneling machinery at the West Portal will be smaller but more versatile than at the East Portal. First, an excavator breaks up the concrete on the wall, creating an entryway for the tunnel. The crew cuts steel within the concrete wall with blow torches.

After a tunnel-sized hole is made in the portal wall, the excavator, now equipped with a cutting head, will begin tunneling. The cutting head spins rapidly, gouging out chunks of dirt and rock from the face of the tunnel. Afterward, the crew sprays the walls with concrete and installs steel girders and sprays them with concrete. The workers roll the excavator into position again and the process

Program Updates_

Program Compliance: Staff is developing a compliance report based on analysis of the <u>annual audits and reports</u> submitted by 19 local transportation agencies/jurisdictions. The summary describes fiscal year 2009-2010 pass-through fund expenditures (Alameda CTC allocated over \$51.4 million that year). Staff will present it to the Commission in May.

Grant Programs: To date, Alameda CTC has awarded over \$27.2 million to four grant programs. In April, staff recommends Commission approval to extend 13 Cycle 4 Paratransit Gap Grants and provide supplemental funding of just under \$1 million for 10 of the grants. One successful project of note, the <u>Pleasanton Downtown Route</u> <u>Senior Shuttle</u>, recently added eight new stops



repeats as the work crews advance in this manner through the tunnel.

"The start of tunneling from the Alameda side of the Caldecott Tunnel marks an important day for this project," said Mark Green, Chair of the Alameda County Transportation Commission. "We look forward to a smoother, less-congested passage between Alameda and Contra Costa counties upon project completion."

in response to a rider survey, and five flex stops that allow direct transfer opportunities to Wheels fixed-route buses. Approximately 61 percent of riders are over 80 years old.

Federal Grant Application Scoring: The Section 5310 Program provides capital grants for vehicles, radios and dispatching software to assist private nonprofit corporations and public agencies in providing transportation services for seniors and individuals with disabilities. In March, a Paratransit Advisory and Planning Committee subcommittee scored 21 applications and provided scores to MTC, which will submit rankings to Caltrans in May.

Ed Roberts Campus Grand Opening:

On Saturday, April 9, the public celebrated the grand opening of the <u>Ed Roberts Campus</u> (partially funded by a Cycle 3 Paratransit Gap Grant award of \$141,000 and \$7.2 million in funds programmed from the ACCMA), which offers an array of disability-related services and programs in one totally accessible location at the Ashby BART Station.

Over the past month, finance staff has devoted time to budget work for the upcoming fiscal year, consolidate the financial systems and ensure cash-flow stability for the agencies. As part of the budgeting process, staff has worked with a consultant to provide extensive information and to develop agency goals and objectives for the consolidated budget for fiscal year 2011-2012. Staff will also develop a cost allocation plan that will allow for recovery of overhead costs through capital projects.

To facilitate the financial accounting systems consolidation, staff has taken into consideration that the current financial accounting systems were designed differently with varying needs. ACTIA, for the most part, has only one funding source, and the ACCMA has many.

Finance Updates

Consequently, staff is developing a new common chart of accounts and account code string that will capture the funding sources, along with common policies and procedures to ensure budgetary controls in the new consolidated system.

At last month's Commission meeting, the Alameda CTC approved an initial loan of \$5 million from the ACTA to the ACCMA. This \$5 million will help provide cash flow for the ACCMA capital program, now being led by Alameda CTC, while the agency awaits reimbursement from various funding sources on its many projects.

Committee Activities


In April, several community advisory committees met. Highlights include:

- April 5 The <u>Alameda County Technical</u> <u>Advisory Committee</u> discussed the Vehicle Registration Fee and other funding sources.
- April 7 The <u>Community Advisory</u> <u>Working Group (CAWG)</u> discussed transportation issue papers, polling results and project/program packaging methods for Countywide Transportation Plan and Transportation Expenditure Plan (CWTP-TEP) development.

- April 14 The <u>Technical Advisory Working</u> <u>Group (TAWG)</u> discussed the same items as CAWG.
- April 14 The <u>Bicycle and Pedestrian</u> <u>Advisory Committee</u> recommended a matching fund policy for the Countywide Discretionary Fund Program and discussed continuation of current bike/ped programs.
- April 25 The <u>Paratransit Advisory and</u> <u>Planning Committee</u> held a joint meeting with the Paratransit Technical Advisory Committee and made recommendations on gap grant funding and on the paratransit coordination contract.
- April 28 The <u>CWTP-TEP Steering</u> <u>Committee</u> discussed CAWG/TAWG items and commented on committed projects, the funding policy and the Initial Vision Scenario.

East County Transportation Forum

On April 21, the Alameda CTC in conjunction with the Citizens Advisory Committee hosted the East County Transportation Forum at Dublin City Hall. Presentations included Alameda Countywide Transportation Planning, Route 84 Expressway Update, I-580 Corridor Update, Alameda Canal Trail Update and WHEELS Transit Advancements.
