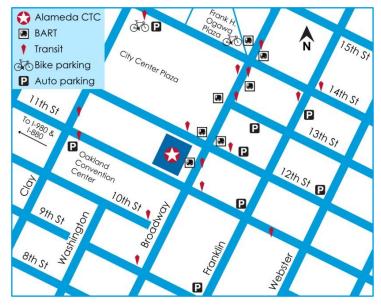

1. Welcome and Roll Call

Krystle Pasco called the meeting to order and a roll call was conducted. All members were present with the exception of Raymond Figueroa, Brad Helfenberger, Travis Huang, Ely Hwang, Jay Jeter, Paul Keener, Isabelle Leduc, Julie Parkinson, Kim Ridgeway, Leah Talley and David Zehnder.

2. Public Comment

There were no public comments.

3. Administration

3.1. Review the March 14, 2017 ParaTAC Meeting Minutes

Committee members received the March 14, 2017 ParaTAC meeting minutes and agreed by acclamation.

3.2. Review the FY 2017-18 ParaTAC Meeting Calendar

Krystle Pasco noted that there are two upcoming joint meetings. The meeting in October 2017 will provide an overview and best practices discussion on Volunteer Driver Programs. The February 2018 meeting will provide an overview and discussion on Mobility Management.

3.3. PAPCO Roster

The PAPCO roster was provided in the agenda packet for review purposes.

3.4. Paratransit Outreach Calendar

The paratransit outreach calendar was provided in the agenda packet for review purposes.



4. Paratransit Programs and Projects

4.1. Implementation Guidelines and Performance Measures Review and Update

Naomi Armenta stated that the Implementation Guidelines for the Special Transportation for Seniors and People with Disabilities Program and performance measures are periodically reviewed and updated. She noted that the performance measures are new as of FY 2016-17. The Implementation Guidelines apply to all projects funded by Measure B, Measure BB, Vehicle Registration Fee, Direct Local Distribution funded programs and discretionary programs as mandated by the Comprehensive Investment Plan.

The committee discussed the eligible service types in the Guidelines and provided input on the guidelines and the Performance Measures. The discussion included:

- Rename Taxi Subsidy to Taxi Subsidy/Same Day
 Transportation
- List Transit Orientation Services under Mobility Management and Travel Training
- Consider changing the Taxi Subsidy detail to include "fixed or flex for seniors..."
- Suggested cleaning out the total registrants data on a regular basis
- Acknowledge difficulty in collecting accurate data on lift or ramp assisted trips; difficulty around collecting data on same day transportation option on vehicles that are accessible
- Distinguish the services listed as either door-to-door, curb-tocurb or both.
- 4.2. Update on Hospital Discharge Transportation Service (HDTS) and Wheelchair Scooter Breakdown Transportation Service (WSBTS) Programs and Same Day Accessible Transportation Options Krystle Pasco stated that the HDTS program began in 2004 and the WSBTS program began in 2005. In March 2017, the contracted transportation provider for both the HDTS and WSBTS programs notified the Alameda CTC that they were not interested in extending their contract past June 30, 2017 due to low usage and ongoing challenges in delivering the service. As a result, Alameda CTC phased out the HDTS and WSBTS programs as of June 2017.

She noted that Alameda CTC is currently seeking a new service provider for the WSBTS service.

Laura Timothy asked if Alameda CTC considered separating out non-functional power chairs because they are difficult for operators to handle.

Laura Timothy asked for the cost per trip. Ms. Pasco stated that the cost for per trip is fixed and the HDTS cost was \$40 per trip and the WSBTS cost was \$80. Ms. Timothy asked if Alameda CTC would consider changing the cost to attract providers. Cathleen Sullivan stated that the providers were not willing to negotiate at a higher cost because they did not see a model where it would be cost effective.

Dana Bailey asked if Alameda CTC received feedback from the hospitals when they realized the programs were going away. Ms. Pasco stated that two of the hospitals expressed concern and had interest in finding out other transportation options in the meantime. She provided the hospitals with a list of local programs.

4.3. Mobility Management

Krystle Pasco asked for mobility management updates and coordination. Naomi Armenta provided an update on the September 8, 2017 countywide mobility management meeting. She noted that the group will meet again in November 2017.

4.4. Emergency Preparedness

Naomi Armenta stated that she's been communicating with Corinne Bartshire who is the Resilience and Recovery Project Manager for the Bay Area Urban Areas Security Initiative (UASI). She noted that she is on the distribution list to receive information from the Care and Shelter Subcommittee. Naomi shared that a Local Government Care and Shelter Gap Identification Tool was developed to assist cities in identifying gaps that local governments may have for care and shelter in case of a catastrophe. She will keep ParaTAC informed about the workshops, best practices, and tabletop exercises that will take place to provide local governments with an opportunity to discuss agency roles and responsibilities.

Dana Bailey shared that she's on the Care and Shelter Operations Subcommittee. On August 23, 2017, Dana attended the Care and Shelter best practices workshop at the Alameda County Sheriff's Department in Dublin. She shared that the Red Cross is relied upon for small and large disasters and catastrophic events and Homeland Security is relying on cities and counties to respond.

Laura Timothy noted that East Bay Paratransit (EBP) completed their Emergency and Disaster Plan. Annually they practice their emergency preparedness roles. She noted that paratransit coordinators around the region get together to review and discuss ADA emergency preparedness plans and issues.

4.5. Technical Exchange

Laura Timothy asked if anyone has any experience with the Santa Clara Valley Transportation Authority (VTA) and their account based system. She noted that as of July 1, 2017 VTA will no longer allow client accounts to become negative. She noted that the clients will need to have a credit card on file or mail in a check. This change will certainly impact EBP regional trips.

Hakiem McGee asked if there is an ADA database and who has access. Laura Timothy said that AC Transit is the current administrator of the database and she suggested reaching out to Victoria Eisen.

5. Committee and Transit Reports

5.1. PAPCO Update

Krystle Pasco informed the committee that the next PAPCO meeting is Monday, September 25, 2017.

5.2. ADA and Transit Advisory Committee Updates

Victoria Williams said that Arnold Brillinger is the new EBP SRAC president and the next meeting is Tuesday, November 7, 2017.



6. Member Reports

There were no member reports.

7. Staff Reports

Krystle Pasco informed the committee that Alameda CTC is looking to sunset the paratransit information line at the end of December 2017. Currently, staff is receiving approximately five to seven calls a week. Staff will now redirect callers to 211.

Krystle also gave an update on the paratransit funding formula.

8. Adjournment

The meeting adjourned at 11:30 a.m.

Summary

On January 9, 2018 ParaTAC will receive Draft Direct Local Distribution (DLD) Estimates for FY 2018-19.

Background

Planning Areas

Alameda CTC is divided into four planning areas:

- North County = the cities of Albany, Alameda, Berkeley, Emeryville, Oakland, and Piedmont
- Central County = the cities of Hayward and San Leandro and unincorporated areas
- South County = the cities of Fremont, Union City, and Newark, as well as Union City Transit
- East County = the cities of Livermore, Dublin, Pleasanton, and unincorporated areas, and LAVTA

Measures B and BB Paratransit Direct Local Distribution funding is split by planning area and within each planning area by formula. The details for how funding is distributed are described here.



Measure B Planning Area Funding Distribution

Per the Alameda County Transportation Commission's 2000 Transportation Expenditure Plan (TEP), 10.45% of Measure B funds go to specialized transportation for seniors and people with disabilities, as follows:

- 5.63% allocated to ADA-mandated paratransit services
- 3.39% allocated to non-mandated paratransit services
- 1.43% allocated to the Gap Grant Program

The 2000 TEP also specifies that the 3.39% allocated to non-mandated paratransit services be distributed to the planning areas as follows:

- North County = 1.24%
- Central County = 0.88%
- South County = 1.06%
- East County = 0.21%

These allocations were determined as part of the negotiations to craft the 2000 TEP for Measure B sales tax revenues.

Measure BB Planning Area Funding Distribution

Per the Alameda County Transportation Commission's 2014 Transportation Expenditure Plan (TEP), 10% of Measure BB funds are allocated to affordable transit for seniors and people with disabilities, as follows:

- 6% allocated to East Bay Paratransit Consortium
- 3% allocated to cities and local transit operators
- 1% allocated for service gaps and coordination

The 2014 TEP also specifies that the 3% allocated to cities and local transit operators will be distributed to each of the four planning areas based on the percentage of the population over age 70.



Measures B and BB Funding Formula for City Funding Distribution

Both Measure B and BB specify that PAPCO develops, and the Alameda CTC Commission adopts, a funding formula to allocate funding within each planning area to the individual agency recipients. Funds from a planning area may not be transferred to another area.

The initial funding formula was adopted in 2003 and expired in June 2012. In late 2011, PAPCO and ParaTAC convened a subcommittee to review the formula used for the distribution of Measure B funds and discussed options for a new funding formula. The group discussed three areas of concern that impact a community's need for accessible transportation: age, disability, and income. Unfortunately, reliable data relating to disability was not available at that time. After extensive discussion, the Subcommittee recommended using age as a proxy for disability. The resulting formula that was adopted includes the following three factors:

- Seniors age 70-79
- Seniors age 80+ (weighted times 1.5 as a proxy for disability)
- Low-income households earning less than or equal to 30% of Area Median Income (in the current proposal, this is calculated as <\$20,000 annually)

This new funding formula took effect July 1, 2012. The committee proposed that the formula remain in effect for 5 years. They also determined that the source for age data should be Census 2010, and the source for income data should be the American Community Survey (ACS), updated annually to take advantage of improved accuracy due to the increasing sample size.

In 2014, disability data became available due to the ACS sample size becoming large enough that data about disability was available for every city and unincorporated area in Alameda County. Measure BB also passed in 2014. In November 2014, PAPCO made three changes to the funding formula, in accordance with ParaTAC and staff recommendations:

- 1. ACS disability data was added to the funding formula, *in addition* to the proxy that was being used for disability (population of seniors age 80+ multiplied by 1.5). This was in accordance with the ParaTAC recommendation; ParaTAC members pointed out that many older seniors do not identify themselves as disabled, and therefore may not be captured by ACS data, and recommended the weighting for seniors 80 and over be retained.
- 2. The data source for population was changed from Census 2010 to the ACS as it was deemed to be the most current and accurate data available and it was being used for the other funding formula factors, income and disability.
- 3. The funding formula was applied to Measure BB funds as well as Measure B funds.

Current Funding Formula and Projections

In January 2017, PAPCO reviewed the funding formula and the most recent projections at that time. They took action to extend the current formula for the same length of time as the Master Program Funding Agreements, with annual updates of American Community Survey (ACS) data. The table below shows the factors included in the current funding formula for both Measure B and BB funds.

These estimates should be used by ParaTAC in preparing the FY 2018-19 Program Plans, which will be due in late March.
