Jurisdiction	Question	Answer
Emeryville	What are eligible projects under the Transit Program?	Project applications related to transit improvements may include capital infrastructure and facility improvements such as bus shelter improvements, transit lane striping, shuttle operations.
Emeryville	If we have a transit and bicycle/pedestrian related improvement, how do we classify the project?	Applicants will be asked to identify the primary mode that project seeks to address. The applicant questions for bicycle/pedestrian and transit improvements are the same.
Alameda	Would water shuttle operations be funded by TFCA or other means?	There may be a few fund sources available in the CIP that may be eligible to fund components of the operations. However, we need additional information to fully determine the cost eligibilities. Please contact Alameda CTC to discuss your projects before pursuing an application.
Alameda	What is the difference between the selection criteria and programming priorities, and how they work together?	The Selection Criteria and Programming Priorities are very similar and have overlap. The selection criteria are an outline of the technical elements that projects should fulfill to be competitive and eligible. The Programming Priorities highlights specific components of the scoring criteria such as construction implementation in the first two years of the CIP, 10-year priority in the CTP, etc. that Alameda CTC will be specifically look for to help narrow the field of candidate projects
ACPWA	Is construction engineering for our inspectors an eligible cost?	Yes. This is an eligible cost.
ACPWA	Would a project the 10-year CTP Priority List more of a priority over a project from the programmatic?	Yes. Alameda CTC will be looking to prioritize funding proposals from the 10-year Priority List. We expect applications to be consistent with those near-term priorities. In the event applications are from the programmatic list, Alameda CTC will review and consider the applicant's prioritization of each application.
