

#### **Budget Update Summary**

- Update beginning fund balance to reflect ending fund balance from audited financial statements in the CAFR for the year ended June 30, 2020
- Update revenues and expenditures consistent with the Comprehensive Investment Plan, by fund type, to allow for the change in needs since the FY2020-21 budget was adopted in May 2020
- Includes the allowance for a short-term, interfund loan of up to \$125 million from the 1986 Measure B program to the 2014 Measure BB Capital program which would delay the need for external financing

#### Overview of Budget Update

Significant programming, planning, and programs activities in the budget include:

- Measure B and Measure BB Direct Local Distributions and Discretionary Grants Funding Programs
- Vehicle Registration Fee Program
- Transportation Funds For Clean Air Program
- Safe Routes to School (SR2S) Program
- Congestion Management Programs
- Transportation Planning Projects (e.g. UC BART Station Improvements and AC Transit Rapid Bus Corridor Upgrades)
- Affordable Student Transit Pass Program

- Route 84 Expressway South Segment Project
- Warm Springs BART West Side Access
- Union City Blvd. Bike Lanes Phase 2
- Hesperian Boulevard Corridor Improvements Project

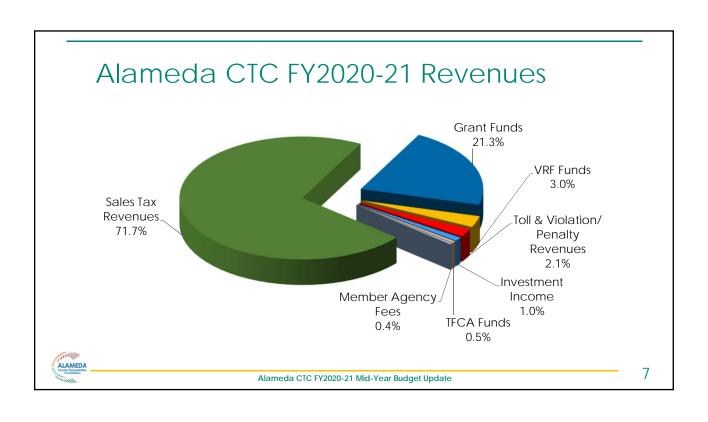

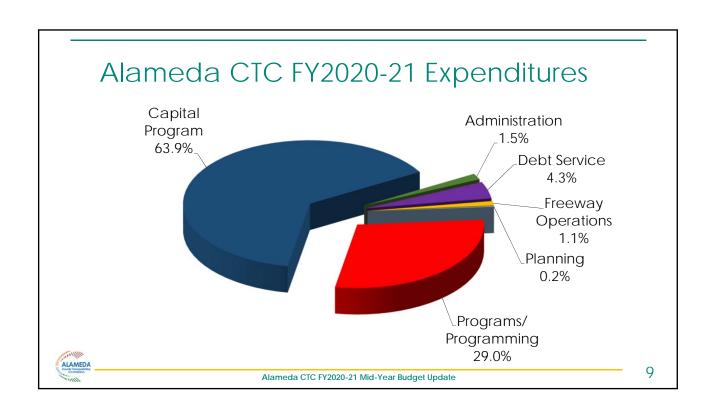

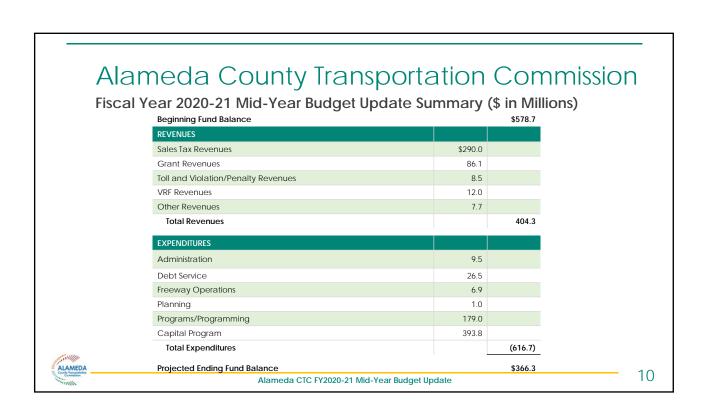
