

Budget Development Goals

- Includes revenues and expenditures necessary to provide vital transportation programs and planning projects to deliver significant capital projects that expand access and improve mobility in Alameda County consistent with the Comprehensive Investment Plan.
- Allocate available resources and provide funding for:
 - Critical planning activities to implement accessible, affordable, and equitable multimodal projects
 - Programming activities for various internal and external funds under purview
 of the Alameda CTC to advance projects, programs and policies that support
 sustainable transportation, reducing emissions and increasing mobility options
 - Delivery of multimodal projects to support investments in active transportation, economic vitality, jobs, safety and access in Alameda County

Overview of Proposed Budget (cont'd)

Significant programming, planning, and programs activities in the budget include:

- Measure B and Measure BB Direct Local Distributions and Discretionary Grants Funding Programs
- Vehicle Registration Fee Program
- Transportation Funds For Clean Air Program
- Safe Routes to School (SR2S) Program
- Affordable Student Transit Pass Program
- Congestion Management Programs
- Transportation Planning Projects (e.g. multi-modal plans, I-580 Sustainable Corridor Strategy)

Significant capital projects in the budget by phase include:

Construction:

- GoPort Program of Projects FITS
- I-80 Gilman Interchange Improvements
- SR-84 Widening and SR-84/I-680 Interchange Improvements
- Hesperian Boulevard Corridor Improvements

Design:

- I-680 Express Lane Southbound Gap Closure
- GoPort Program of Projects 7SGSE, 7SGSW
- Union City Boulevard Bike Lanes Phase 2
- Irvington BART Station
- Quarry Lakes Parkway

Overview of Proposed Budget (cont'd)

Significant capital projects in the budget by phase include:

Environmental:

- SR-262 (Mission Boulevard) Cross Connector
- Oakland Alameda Access
- I-80 Ashby Interchange Improvements
- I-880 Whipple Industrial Interchange Improvements
- I-880 Winton- A Street Interchange Improvements

Planning:

- East 14th/Mission and Fremont Blvd. Multimodal Corridor
- San Pablo Avenue Multimodal Corridor (Planning and Environmental Phase)

Overview of Proposed Budget (cont'd)

Assumes a short-term, inter-fund loan of up to \$125.0 million from the 1986 Measure B Capital Fund to the Measure BB Capital program, which would delay the need for external financing for the Measure BB Capital program to FY2022-23 based on most recent cash flow projections.






