STPP Expansion Milestones

December 2018

- Commission approval for STPP continuation and expansion

2019-20 Expansion

- Onboarded 62 schools

2020-21 Expansion

- Onboarded 84 schools


• 2021-22 Approach

- Continue at all currently participating STPP schools



2021-2022 School Year and COVID-19 Impacts

- All STPP schools opened for 100% in-person learning
- Online application
- Ongoing coordination with STPP Alameda County School Districts schools, and transit agencies
- Applications have been received from all participating school districts.



2020-21 School Year Evaluation

- Due to COVID-19, half of all STPP schools remained in virtual learning for entire school year
- More than 12,500 participating students
- **33 percent** participation rate



Remaining Expansion Districts

- Implement over two years
 - 50+ additional schools, over 17,000 eligible students
- Contingent upon discussions with transit agencies and cooperation from school districts.

Districts with Remaining Schools

- Alameda USD, **34 percent FRPM** (7 schools)
- Berkeley USD, **36 percent FRPM** (2 schools)
- Fremont USD, **15 percent FRPM** (9 schools)
- Oakland USD, **75 percent FRPM** (33 schools)

New District

- Piedmont USD, **2 percent FRPM** (3 schools)



Student Transit Pass Program Next Steps

- Continue outreach with schools on the benefit of the STPP Youth Clipper Card and program
- Ongoing coordination with school districts and transit agency partners
- Finalize STPP 2020-21 annual evaluation, to be finalized in spring 2022
- Financial viability of program
