### 7. IWC Annual Report, Publication Methods and Costs, and Press Release

#### 7.1. Approve the Draft IWC Annual Report and Findings

(This item was presented after 6.1) IWC members discussed the findings in the report and asked staff to provide the following message to the Commission:

"The Independent Watchdog Committee acknowledges that the last quarter of FY 2019-20 was marked by the onset of the Coronavirus-19 (COVID) pandemic with the resulting statewide "lockdown." This resulted in noteworthy impacts to both community life and public agencies' planning, implementation, and public meeting activities, lasting throughout at least most of FY 2020-21.

The IWC is required to evaluate the effectiveness and benefits of the Measure BB DLD programs based on performance measures adopted by the Alameda CTC. The performance measurement vary depending on the program (i.e., transit, streets and roads, etc.). Based on the established measurements and the data submitted as an annual "snapshot" by the DLD recipients, we do not believe that a determination can be made of the effectiveness of the Measure BB expenditures since inception. In several instances, performance measurement and/or the data provided is not sufficient to ascertain the impact of the Measure BB expenditures and what progress has occurred. In most cases, there is no documentation of the leveraging of other fund sources by Measure BB recipients. Further, the adopted performance measures should be reviewed to identify additional measures of public benefit.

Recommendation: In order to address this issue, the IWC has recommended that periodically (i.e., every 3-5 years), the Alameda CTC engage an independent party to conduct an overall comprehensive analysis of the Measure BB DLD program performance, which need not be expensive. In response to the IWC's initial requests, Alameda CTC staff has compiled a preliminary summary of performance trends by jurisdiction and program; we believe that this data should be public through a regular report to the Commission. As one example, several cities have consistently fallen short of the adopted Pavement Condition Index for their Local Streets & Roads programs."

Murphy McCalley moved to approve this item with the specific recommendation above in a memo to the Commission. Ed Hernandez seconded the motion. The motion passed with the following votes:

FY2019-20 Measure B and Measure BB Program Compliance Summary Report John Nguyen presented this item to provide the IWC with an update on Measure B and Measure BB DLD Program Compliance for the Fiscal Year 2019-20 reporting period. Mr. Nguyen reviewed the compliance requirements, recipients' expenditures, and program performance. Mr. Nguyen stated that all recipients were in compliance with the program.

#### 11. Measure B/Measure BB Projects

#### 11.1. Measure B and Measure BB Capital Project Update

Joy Sharma provided an update on Measure B and Measure BB capital projects. The presentation covered funding highlights from the sales tax programs and information on project management and corridor improvements. Ms. Sharma provided details on projects directly managed by Alameda CTC, updating the Committee on 2020 and 2021 milestones, achievements, as well as anticipated milestones for the coming fiscal year.

#### Recommendation

This item is an update on outreach activities and costs for the 19th Annual IWC Report to the Public for informational purposes only.

#### Summary

The Independent Watchdog Committee (IWC) released its 19th Annual Report to the Public in August 2021. Multiple activities including publication distribution, advertisement placement, and targeted outreach were completed to make the public aware of the report. With the Coronavirus (COVID-19) pandemic, and the resultant shelter-in-place order across the Bay Area Counties, Alameda CTC outreach approach was slightly modified from prior years.

#### Background

A key responsibility of the IWC is to keep the public informed about the progress of transportation programs and projects funded by Measure B and Measure BB sales tax dollars and if the use of these funds is compliant with requirements in the voter-approved Transportation Expenditure Plans.

Annually, the committee generates a report for the public to report its findings on the use of sales tax dollars and other activities. At the March 2021 IWC meeting, some committee members volunteered to participate in the IWC Annual Report Subcommittee. The subcommittee met twice to develop the 19th Annual IWC Report to the Public and discuss outreach strategies. The development and outreach approach of the annual report included:

- Meetings to discuss report content and work with staff to write, design, print, and distribute the report.
- Hold a public hearing to get input from the public before finalizing the report.

- Obtain input and approval from the full committee on the report before finalizing the report.
- Email a message about the annual report to Alameda CTC's full Constant Contact mailing list, once the report was published.
- Notify the media of the report through a press release and place print and online advertisements in the media (see "Media Placement" section below).
- Design and place bus exterior cards advertisement on AC Transit buses. In prior years, staff placed a bus interior card advertisement on buses; however, since people are avoiding transit due to the pandemic, the Committee suggested placing the advertisements outside versus inside.
- Set up Google Alerts to track when the annual report and the IWC were in the news.
- Design and place bus exterior cards on Livermore Amador Valley Transit Authority (LAVTA) buses.
- Design and place advertisement in San Francisco Bay Area Rapid Transit District (BART) stations in Alameda County. In prior years, advertisements were placed in-station as well as outside of the BART stations. The Committee requested BART advertisements to be placed closer to the entrances of the various stations for more visibility.
- Create a two-page executive summary of the annual report in English, hyperlink it to additional information about Measure B and Measure BB projects and programs, and translate it into Chinese and Spanish.
- Have Dakota Press print the annual report and two-page executive summary in English and translate executive summaries. In prior years, staff would print the translated executive summaries in-house; however, this process changed due to the sheltered in place order and the COVID-19 pandemic.
- Translate two advertisements from English to Spanish and place them in two publications.

### Media Placement

The IWC approved the media placement plan and budget (see Attachment 7.1A). Staff placed online ads in various media with a link directing traffic to the IWC Annual Report page of the Alameda CTC website <u>https://www.alamedactc.org/wp-content/uploads/2021/08/IWC2021Report.pdf</u> and placed print advertisements that summarize the full report in 19 Bay Area publications (see Attachment 7.1 for a complete list). In addition, staff placed online banner advertisements that included a link to the IWC 19<sup>th</sup> Annual Report to the Public <u>https://www.alamedactc.org/IWC2021Report</u>.

### AC Transit Bus and LAVTA Bus Exterior Cards

Staff worked with Lamar Advertising to place 40 Queen posters on the side of AC Transit buses and five (5) Queen posters on the side of LAVTA buses that operate in Alameda County.

Staff worked with Outfront Media to place posters at the following 12 BART stations in Alameda County:

### Print Publications

A printer, certified in Alameda CTC's LBCE program, printed 250 copies of the full 12-page annual report and 250 copies of the English-version executive summary with notification of the report and the short URL. The printer printed 150 copies each of the Chinese and Spanish versions of the executive summary. (Refer to Attachment 7.1A for design and print costs.)

### Constant Contact E-Blasts

- **Press release** was sent to 276 media contacts, sent 250 to newspapers, blogs, ethnic media, radio, and television on August 13, 2021. The press release email was opened by 61 recipients. Attached is a report from Constant Contact that documents click-through statistics.
- The IWC Annual Report was also mentioned in the July and September issues of the Executive Director's Report.

### Social Media

Alameda CTC used social media including Twitter and Facebook to inform the public about the IWC Annual Report.

Both reports were posted on the Alameda CTC website, and an email was distributed to 111 addresses.
- Placed "What's New" information on the Alameda CTC website that links directly to the report.
- Mailed the full report and the English, Spanish and Chinese language executive summaries to:
  - o 46 libraries in Alameda County
  - 16 chambers of commerce for the cities of Alameda, Albany, Berkeley, Castro Valley/Eden Area, Dublin, Fremont, Hayward, Livermore, Newark, Oakland, Pleasanton, San Leandro, and Union City; and three ethnic chambers including the Hispanic Chamber of Alameda County, the Oakland African American Chamber of Commerce, and Oakland Chinatown Chamber of Commerce
  - IWC members and organizations 13 IWC members, Alameda County Mayors' Conference (Districts 1, 2, 3, 4, 5), Alameda County Taxpayers Association, Alameda Labor Council AFL-CIO, Bike East Bay, Board of Supervisors (Districts 1, 2, 3, 4, and 5), East Bay Economic Development Alliance, League of Women Voters, and Sierra Club

**Fiscal Impact**: The total cost of design and placement of the online and print advertisements, and the printing and mailing of the hard copy 2021 report are approximately \$47,912.49.

In 2020, the total costs were \$48,559.92. The budget in 2021 for the IWC 19th Annual Report to the Public was \$50,000. The 2021 approximate costs are \$647.43 less than the prior year and \$2,087.51 under budget. One vendor has not yet submitted an invoice related to 2021 costs due to delays in processing related to the pandemic. The estimated amount is highlighted in yellow in Attachment A.







#### Recommendation

This item is to provide the Independent Watchdog Committee (IWC) with information on the Measure B and Measure BB Direct Local Distribution (DLD) performance measures, including background on the Transportation Expenditure Plan requirements, metric development, and performance monitoring processes. This item is for information only.

#### Summary

Alameda CTC is responsible for the distribution of revenues generated through the 2000 Measure B and 2014 Measure BB Transportation Expenditure Plans (TEPs). The 2014 Measure BB Transportation Expenditure Plan (2014 TEP) requires the establishment of performance measures for accountability and to inform the public on the investments of voter approved transportation dollars.

On February 25, 2016, the Commission approved performance measures and implementation guidelines which guides the use and accountability of Measure B and Measure BB Direct Local Distribution (DLD) program funds. The DLD performance measures reflect best practice, industry standard metrics deployed throughout the transportation industry for local streets and roads, bicycle/pedestrian and transit projects and program operations. Development of the DLD performance metrics included input from Alameda County Technical Advisory Committee (ACTAC), Paratransit Technical Advisory Committee (PTAC), and Paratransit Advisory and Planning Committee (PAPCO), and consultation with other transportation agencies.

Each December, DLD recipients are required to submit Audited Financial Statements and Program Compliance reports. Alameda CTC staff and the IWC review the recipients' reports for program compliance to the TEP guidelines and Master Program Funding Agreement (MPFA) requirements. Through this process, Alameda CTC and the IWC review expenditures and performance accomplishments reported and may request additional information, as necessary. A summary of DLD financials, compliance determination, and performance accomplishments are provided to the Commission and the IWC each year in early Summer.

#### Background

#### Transportation Expenditure Plan Requirements

Alameda CTC is responsible for administering the Measure B and Measure BB sales tax programs. Over half of Measure B/BB revenues generated are returned directly to twenty eligible jurisdictions as "Direct Local Distribution" (DLD) funds via a prescribed distribution formula set within the respective Measure B/BB Transportation Expenditure Plans. Annually, DLD funds support locally identified transportation improvements related to local streets and roads, bicycle/pedestrian improvements, transit and paratransit programs.

The 2014 Measure BB Transportation Expenditure Plan (2014 TEP)'s Implementation Guidelines (No. 6, 7, and 11) outline requirements for establishing accountability through master agreements, performance metrics, and performance monitoring for Measure B/BB funds (see Attachment A: 2014 TEP Implementation Guidelines Excerpt for No. 6, 7, and 11).

The 2014 TEP Implementation Guideline No. 6 defines the IWC's role in evaluating and reporting on performance as follows:

"The Independent Watchdog Committee will prepare an annual report on spending and progress in implementing the Plan that will be published and distributed throughout Alameda County. On a periodic basis, the Independent Watchdog Committee will review the performance and benefit of projects and programs based on performance criteria established by Alameda CTC as appropriate."

On February 25, 2016, the Commission approved a ten-year MPFA for Measure B and Measure BB DLD recipients. The MPFA identifies Alameda CTC's and recipient's roles and responsibilities, policies on expenditures, timely use of funds requirements, and performance measures to which recipients must adhere in order to comply with the requirements in the TEP. The duration of the MPFA is from July 1, 2016 to June 30, 2026. Alameda CTC monitors compliance with requirement in the MPFA and TEP through the annual program compliance reporting process.

#### DLD Performance Measures Development and Considerations

The performance measures for the DLD program that were approved by the Commission and included in the MPFAs were developed in consultation with technical engineering and planning staff from the Alameda County Technical Advisory Committee (ACTAC), Paratransit Technical Advisory Committee (PTAC), Paratransit Advisory and Planning Committee (PAPCO), and standards established by regional, State, and federal agencies.

Alameda CTC staff considered multiple factors for the DLD Performance Measures:

- Performance metrics origins are based on standard industry best practices used by peer agencies at the regional, State and federal level. This includes the Federal Transit Agency (FTA), Caltrans, Metropolitan Transportation Commission (MTC), Mineta Transportation Institute, San Francisco County Transportation Authority and Contra Costa Transportation Authority.
- Performance metrics must reflect quantifiable data on universal investments such as pavement condition index for streets and roads, quantities of sidewalk or bike facility improvements, revenue hours, transit ridership, and trips provided/individuals served.
- Performance metrics serve to provide information on service availability, transit access, service reliability, safety and security, community impact, financial accountability, and delivery performance of projects and programs.
- Transportation system performance and trends are reported and monitored across multiple plans such as FTA's transit triennial reviews, California's Asset Management Plan, MTC's Regional Transportation Plan and Street Saver/Vital Signs report, Alameda CTC's Countywide Transportation Plan, transit operators' Short and Long Range Transit Plans, annual DLD program compliance reporting process, annual paratransit program plan review, annual Alameda County performance report, congestion management plan/levels of service monitoring report, and other planning activities.
- Performance monitoring considers changing conditions in the real world.
- Performance evaluation considers fluctuations occurring from year to year due to varying transportation needs and/or project and program needs.
- Performance evaluation considers DLD recipient's annual expenditures and goals rather than comparative to other DLD recipients.

Extensive federal, State, and regional performance reporting is required by all jurisdictions. Alameda CTC as the congestion management agency for Alameda County publishes an annual performance report each year noting the jurisdiction's performance across transit, roadway aerials, highway, active transportation, and freight: <u>https://www.alamedactc.org/planning/congestion-management-program/</u>.

To focus and streamline DLD reporting, the DLD performance measures reflect quantifiable metrics used within the transportation industry to monitor items such as pavement condition index for streets and roads, quantity of sidewalk or bike facility improvements, transit ridership, and trips provided/individuals served. The performance metrics require jurisdictions to also report on specific DLD funded projects and their qualitative benefits, e.g. gap closures, safety improvements, network connectivity, access improvements (see Attachment B: DLD Agreement Performance Measures).

#### DLD Program Compliance Summary Report and Performance Monitoring

As part of the DLD program compliance process, each December, Alameda CTC requires DLD recipients to submit audited financial statements and program compliance reports to document the receipt and use of DLD funds in arrears. Alameda CTC, in conjunction with the IWC, reviews the reports to verify DLD funds are expended in compliance with the TEP and MPFA requirements, including performance reporting.

Through the compliance reporting process, Alameda CTC and the IWC have an opportunity to investigate DLD expenditures and request additional information from DLD recipients to help determine their program compliance. DLD recipients who have targets for certain performance metrics (such as pavement condition index, ridership, on-time performance) are required to provide information if targets have not been met to clarify why the target metric was not met and a corrective action plan using DLD funds and other sources to address their performance in the future.

The DLD recipients' annual financial statements and compliance reports are available for review online at: <u>https://www.alamedactc.org/funding/reporting-and-grant-forms/</u>.

#### Commission and IWC Reporting and Publications

On June 24, 2021, Alameda CTC staff presented to the Commission the annual program compliance summary report and compliance determination for the reporting Fiscal Year (FY) 2019-20. All twenty DLD recipients were found to be in-compliance with the reporting, expenditure requirements, and DLD policies (see Attachment C: Commission FY 2019-20 Program Compliance Summary Report and performance trend data). The Commission staff report (Item 8.2) is available on the Alameda CTC website: https://www.alamedactc.org/events/alameda-ctc-commission-meeting-31/.

On July 12, 2021, the IWC received the same program compliance summary report, compliance determination, and performance information for Measure B/BB funds.

IMPLEMENTING GUIDELINES

This Transportation Expenditure Plan (Plan) is guided by principles that ensure that the revenue generated by the sales tax is spent only for the purposes outlined in this Plan, in the most efficient and effective manner possible, consistent with serving the transportation needs of Alameda County.

### DURATION OF THE PLAN

The duration of the Plan will be 30 years from April 2015 through March 31, 2045.

### ADMINISTRATION OF THE PLAN

- 1. **Funds only Projects and Programs in the Plan**: Funds collected under this measure may be spent only for the purposes identified in the Plan, as it may be amended by the Alameda CTC governing body.
- 2. All Decisions Made in Public Process: Alameda CTC is given the fiduciary duty of administering the transportation sales tax proceeds in accordance with all applicable laws and with the Plan. Activities of the Alameda CTC Commission will be conducted in public according to state law, through publicly noticed meetings. The annual budgets of Alameda CTC, strategic plans and annual reports will all be prepared for public review. The interests of the public will be further protected by an Independent Watchdog Committee, described previously in this Plan.
- 3. Salary and Administration Cost Caps: Alameda CTC will have the authority to hire professional staff and consultants to deliver the projects and programs included in this Plan in the most efficient and cost-effective manner. The salaries and benefits for administrative staff hired by Alameda CTC for this tax will not exceed 1% of the net proceeds of the sales tax.

The total of all administrative costs for this tax including overhead costs such as rent and supplies will be limited to no more than 4% of the net proceeds of this sales tax.

The allocated cost of Alameda CTC staff who directly implement specific projects or programs are not included in administrative costs.

- 4. **Amendments Require 2/3 Support**: To modify and amend this Plan, an amendment must be adopted by a two-thirds vote of the Alameda CTC Commissioners. All jurisdictions within the county will be given a minimum of 45 days to comment on any proposed Plan amendment.
- 5. Augment Transportation Funds: Pursuant to California Public Utilities Code 180001 (e), it is the intent of this Plan that funds generated by the transportation sales tax be used to supplement and not replace existing local revenues used for transportation purposes.

# TAXPAYER SAFEGUARDS, AUDITS AND ACCOUNTABILITY

Accountability is of utmost importance in delivering public investments with public dollars. Alameda CTC is committed to transparency and accountability as a public agency along with its many jurisdictional partners. Many safeguards are built into this measure to ensure voter accountability in expenditure of funds.

6. **Annual Audits and Independent Watchdog Committee Review**: Alameda CTC's financial reports are subject to an independent audit by a Certified Public Accountant (CPA) firm, on an annual basis. Expenditures are also subject to an annual review by an Independent Watchdog Committee. The Independent Watchdog Committee will prepare an annual report on spending and progress in implementing the Plan that will be published and distributed throughout Alameda County. On a periodic basis, the Independent Watchdog Committee will review the performance and benefit of projects and programs based on performance criteria established by Alameda CTC as appropriate.

- 7. **Performance and Cost-Effectiveness:** To maximize transportation investments in the Plan, Alameda CTC will evaluate performance and cost-effectiveness of programs and projects, as they are being implemented.
- 8. **Strict Project Deadlines**: To ensure that the projects promised in this plan can be completed in a timely manner, each project will be given a period of seven years from the first year of revenue collection (up to December 31, 2022) to receive environmental clearance approvals and to have a full funding plan for each project. Project sponsors may appeal to the Alameda CTC Commissioners for one-year time extensions.
- 9. **Timely Use of Funds**: Jurisdictions receiving funds for transit operations, ongoing street maintenance, services for seniors and people with disabilities, and bicycle and pedestrian safety projects and programs must expend the funds expeditiously and report annually on the expenditure, their benefits and future planned expenditures. These reports will be made available to the public at the beginning of each calendar year.
- 10. **Annual Budget and Strategic Plan**: Each year, Alameda CTC will adopt an annual budget that projects expected sales tax receipts, other anticipated revenues and planned expenditures for administration, programs and projects. Alameda CTC will also prepare a strategic plan which will identify the priority for projects and dates for project implementation based on project readiness, ability to generate leveraged funds and other relevant criteria. Both the budget and the strategic plan will be adopted at a public meeting of the Alameda CTC Commissioners.

- 11. **Commitments from Fund Recipients:** All recipients of funds allocated in this expenditure plan will be required to sign a Master Funding Agreement, which details their roles and responsibilities in spending sales tax funds and includes local hiring requirements. Funding agreements will include performance and accountability measures. All funds will be allocated through open and transparent public processes. In addition, fund recipients will be required to have an annual audit conducted by an independent CPA to ensure that funds are managed and spent according to the requirements of this Plan.
- 12. **Capital Improvement Program Updates**: Project descriptions will be detailed and fully defined for inclusion in the Alameda CTC Capital Improvement Program which will be updated every two years and will provide for geographic equity in overall funding allocations. All allocations will be made through a public process.
- 13. **Geographic Equity**: Funding formulas for all programs will be revisited within the first five years of the Plan implementation to ensure overall geographic equity based on population and/or other equity factors. Funding for capital projects will be evaluated through the biennial capital improvement planning process which will include an evaluation of geographic equity by planning area.

#### **RESTRICTIONS ON FUNDS**

- 14. No Expenditures Outside of Alameda County: Under no circumstances may the proceeds of this transportation sales tax be applied to any purpose other than for transportation improvements benefitting Alameda County. Under no circumstances may these funds be appropriated by the State of California or any other governmental agency, as defined in the implementation guidelines.
- 15. Environmental and Equity Reviews: All projects funded by sales tax proceeds are subject to laws and regulations of federal, state and local government, including but not limited to the requirements of the California Environmental Quality Act (CEQA), and

## Independent Watchdog Committee Bylaws

Article 1: Definitions

**1.1 2000 Transportation Expenditure Plan.** The plan for expending transportation sales tax (Measure B) funds, presented to the voters in 2000, and implemented in 2002.

**1.2 2014 Transportation Expenditure Plan.** The plan for expending transportation sales tax (Measure BB) funds, presented to the voters in 2014, and implemented in 2015.

**1.3 Agency.** A business or government organization established to provide a particular service.

**1.4 Alameda County Transportation Commission (Alameda CTC)**. Alameda CTC is a joint powers authority resulting from the merger of the Alameda County Congestion Management Agency ("ACCMA") and the Alameda County Transportation Improvement Authority ("ACTIA"). The 22-member Alameda CTC Commission ("Commission") is comprised of the following representatives:

- 1.4.1 All five Alameda County Supervisors.
- 1.4.2 Two City of Oakland representatives.

**1.4.3** One representative from each of the other 13 incorporated cities in Alameda County.

**1.4.4** A representative from Alameda-Contra Costa Transit District ("AC Transit").

**1.4.5** A representative from San Francisco Bay Area Rapid Transit District

("BART").

**1.5 Alameda County Transportation Improvement Authority (ACTIA).** The governmental agency previously responsible for the implementation of the Measure B half-cent transportation sales tax in Alameda County, as approved by voters in 2000 and implemented in 2002. Alameda CTC has now assumed responsibility for administration of the sales tax.

1.6 Appointing Party. A person or group designated to appoint committee members.

**1.7 At-Large Member.** One of the 10 Independent Watchdog Committee (IWC) members representing supervisorial districts as described in Section 3.1.1 below.

**1.8 Bicycle and Pedestrian Advisory Committee (BPAC).** The Alameda CTC Committee that involves interested community members in the Alameda CTC's policy, planning, and implementation efforts related to bicycling and walking.

**1.9 Brown Act.** California's open meeting law, the Ralph M. Brown Act, California Government Code, Sections 54950 et seq.

**1.10 Expenditures**. Costs incurred and paid for with funds generated from the Measure B and Measure BB sales taxes.

1.11 Fiscal Year. July 1 through June 30.

**1.12 Independent Watchdog Committee (IWC or "Committee").** The Alameda CTC Committee of individuals created by the Commission as required by Measure BB. This Committee was originally created by the ACTIA Board and called the Citizens Watchdog Committee as required by Measure B, and was continued by the Commission subsequent to the passage of Measure BB as the Independent Watchdog Committee. The Committee has the same composition as the Citizens Watchdog Committee required by Measure B. The Committee reports directly to the public and has the responsibility of reviewing all Measure B expenditures and reviewing and overseeing all Measure BB expenditures and performance measures of the agency, as appropriate. IWC members are Alameda County residents who are not elected officials at any level of government, nor individuals in a position to benefit personally in any way from the sales tax.

**1.13 Local Newspapers.** Periodical publications typically published weekly or daily that serve a city, cities or unincorporated communities within Alameda County, whereby the contents are reasonably accessible to the public. On-line publications of these periodicals are included in this definition.

**1.14 Measure B.** The measure approved by the voters authorizing the half-cent sales tax for transportation services now collected and administered by the Alameda CTC and governed by the 2000 Transportation Expenditure Plan. Collections for the sales tax authorized by Measure B began on April 1, 2002 and extends through March 31, 2022.

**1.15 Measure BB.** The measure approved by the voters authorizing the sales tax for transportation services collected and administered by the Alameda CTC and governed by the 2014 Transportation Expenditure Plan. Measure BB augments the half-cent Measure B sales tax by a half cent, beginning April 1, 2015 through March 31, 2022. The full one-cent sales tax authorized by Measure BB will begin April 1, 2022 and will extend through March 31, 2045.

**1.16 Measure B Program.** Transportation or transportation-related program specified in the 2000 Transportation Expenditure Plan for funding transportation programs and projects on a percentage-of-revenues or grant allocation basis.

**1.17 Measure BB Program.** Transportation or transportation-related program specified in the 2014 Transportation Expenditure Plan for funding transportation programs and projects on a percentage-of-revenues or grant allocation basis.

**1.18 Measure B Project.** Transportation and transportation-related capital projects specified in the 2000 Transportation Expenditure Plan for funding in the amounts allocated in the 2000 Transportation Expenditure Plan.

**1.19 Measure BB Project.** Transportation and transportation-related capital projects specified in the 2014 Transportation Expenditure Plan for funding in the amounts allocated in the 2014 Transportation Expenditure Plan.

**1.20 Monitor.** To observe, track, or keep a record of Measure projects, programs, and expenditures.

**1.21 Organizational Meeting.** An organizational meeting of the IWC will be held in July to elect officers and adopt the annual calendar/work plan and review the Alameda CTC budget related to IWC.

**1.22 Organizational Member.** One of the seven IWC members representing organizations as described in Section 3.1.2 below.

**1.23 Oversee.** To watch over Measure BB expenditures and performance measures.

**1.24 Paratransit Advisory and Planning Committee (PAPCO).** The Alameda CTC Committee that meets to address funding, planning, and coordination issues regarding paratransit services in Alameda County. Members must be Alameda County residents and eligible users of any transportation service available to seniors and people with disabilities in Alameda County. PAPCO is supported by a Paratransit Technical Advisory Committee comprised of Measure B and Measure BB-funded paratransit providers in Alameda County.

**1.25 Performance Measures.** Quantifiable methods, adopted by the Commission, used to assess how well the Alameda CTC is achieving its adopted objectives for Measure BB projects and programs.

**1.26 Planning Area.** Geographic groupings of cities and Alameda County for planning and funding purposes. North County: Alameda, Albany, Berkeley, Emeryville, Oakland, Piedmont; Central County: Hayward, San Leandro, unincorporated county (near Hayward); South County: Fremont, Newark, Union City; East County: Dublin, Livermore, Pleasanton, the unincorporated area of Sunol.

**1.27 Subcommittee.** A subset of the IWC, less than a quorum, usually organized for a certain purpose.

#### Article 2: Purpose and Responsibilities

**2.1 Committee Purpose.** The Committee is appointed pursuant to Measure B and Measure BB: 1) to review all expenditures of the Measure B transportation sales tax; 2) to review and oversee all expenditures and performance measures, as appropriate, of the Measure BB transportation sales tax; 3) to monitor Measure B and Measure BB funded projects and programs; and 4) to report directly to the public.

**2.2 Committee Roles and Responsibilities from Expenditure Plan.** As defined by the Measure B and Measure BB Transportation Expenditure Plans, the roles and responsibilities of the Committee include:

**2.2.1** Hold public hearings and issue reports, on at least an annual basis, to inform Alameda County residents about how the sales tax funds are being spent. The hearings will be open to the public and must be held in compliance with the Brown Act, California's open meeting law, with information announcing the hearings well-publicized and posted in advance.

**2.2.2** Have full access to Alameda CTC's independent auditor and have the authority to request and review specific information regarding use of the sales tax funds and to comment on the auditor's reports.

**2.2.3** Publish an independent annual report, including any concerns the committee has about audits it reviews. The report will be published in local newspapers and will be made available to the public in a variety of forums to ensure access to this information.

**2.2.4** Provide a balance of viewpoints, geography, age, gender, ethnicity and income status, to represent the different perspectives of the residents of the county.

2.3 Additional Responsibilities. Additional IWC member responsibilities are to:

**2.3.1** Communicate from time to time to the Alameda CTC by resolution, suggestions and concerns pertinent to the administration and expenditure of Measure B and Measure BB funds.

**2.3.2** Communicate as necessary to recommend that an appointing party appoint a new member when there is a vacancy or upcoming end of term.

#### Article 3: Members

3.1 Number of Members. The IWC will consist of 17 members.

**3.1.1** Ten members shall be at-large, two each representing the five supervisorial districts in Alameda County, one of the two nominated by a member of the Board of Supervisors and one of the two selected by the Alameda County Mayors' Conference.

**3.1.2** Seven of the members shall be nominated by the seven organizations specified in the 2014 Transportation Expenditure Plan: East Bay Economic Development Alliance; Alameda County Labor Council; Alameda County Taxpayers' Association; Alameda County Paratransit Advisory and Planning Committee; Bike East Bay, formerly known as East Bay Bicycle Coalition; League of Women Voters; and Sierra Club.

**3.2 Appointment.** The Commission will make appointments in the following manner:

**3.2.1** Each member of the Alameda County Board of Supervisors shall select one At-Large Member to represent his or her supervisorial district.

**3.2.2** The Alameda County Mayors' Conference shall select one At-Large Member to represent each of the five supervisorial districts.

**3.2.3** Each organization listed in Section 3.1.2 above shall, subject to approval by the Commission, select one organizational member.

**3.3 Membership Qualification.** Each IWC member shall be an Alameda County resident. An IWC member shall not be an elected official at any level of government; or be a public employee of any agency that oversees or benefits from the proceeds of Measure B and Measure BB transportation sales taxes; or have any economic interest in any project or program.

**3.4 Membership Term.** Appointments for at-large members shall be for two-year terms. There is no maximum number of terms a member may serve. Members may serve until the Commission appoints their successor.

**3.5 Attendance.** Members will regularly attend meetings. Accordingly, more than three consecutive absences is cause for removal from the Committee.

**3.6 Termination.** A member's term shall terminate on the occurrence of any of the following:

**3.6.1** The member voluntarily resigns by written notice to the chair or Alameda CTC staff.

**3.6.2** The member fails to continue to meet the qualifications for membership, including attendance requirements.

**3.6.3** The member becomes incapable of continuing to serve.

**3.6.4** The appointing party or the Commission removes the member from the Committee.

**3.7 Vacancies.** An appointing party shall have the right to appoint (subject to approval by the Commission) a person to fill the vacant member position. Alameda CTC shall be responsible for notifying an appointing party of such vacancy and for urging expeditious appointment of a new member, as appropriate.

### Article 4: Officers

**4.1 Officers.** The IWC shall annually elect a chair and vice chair. Each officer must be a duly appointed member of the IWC.

**4.1.1 Duties.** The chair shall preside at all meetings and will represent the IWC before the Commission to report on IWC activities. The chair shall serve as a voting ex-officio

member of all subcommittees except a nominating subcommittee (when the IWC discusses the chair position). The vice chair shall assume all duties of the chair in the absence of, or on the request of the chair.

**4.2 Office Elections.** Officers shall be elected by the members annually at the Organizational Meeting or as necessary to fill a vacancy. An individual receiving a majority of votes by a quorum shall be deemed to have been elected and will assume office at that meeting following the election. In the event of multiple nominations, the vote shall be by ballot. Officers shall be eligible for re-election indefinitely.

### Article 5: Meetings

**5.1 Open and Public Meetings.** All IWC meetings shall be open and public and governed by the Brown Act. Public comment shall be allowed at all IWC meetings. The time allotted for comments by a member of the public in the general public comment period or on any agenda item shall be up to 3 minutes per speaker at the discretion of the chair. Written comments may be submitted prior to the meeting. The number of IWC meetings, including regular meetings, sub-committee meetings, special meetings and public hearings, will be limited to the number of meetings approved in Alameda CTC's annual overall work program and budget, as approved by the Commission.

**5.2 Regular Meetings.** The IWC shall have a regular meeting at least once per quarter. Prior to each Organizational Meeting, the outgoing chair shall cause all members to be canvassed as to their available meeting times and shall recommend the day and time that best accommodates the schedules of all members, giving due regard to accommodating the schedule of any continuing member who has missed meetings due to a conflict in the prior year. Annually, at the Organizational Meeting, IWC shall establish the schedule of regular meetings for the ensuing year. Meeting dates and times may be changed and additional regular meetings scheduled during the year by action of the IWC.

**5.3 Quorum.** For purposes of decision making, a quorum shall consist of at least half (50 percent) plus one of the total number of members appointed at the time a decision is made. Members will not take actions at meetings with less than 50 percent plus one members present. Items may be discussed and information may be distributed on any item even if a quorum is not present; however, no action can be taken, until the Committee achieves a quorum.

**5.4 Special Meetings.** Special meetings may be called by the chair or by a majority of the members requesting the same in writing given to the chair, with copies to the vice chair and the Executive Director, specifying the matters to be considered at the special meeting. The chair or vice chair shall cause notice of a special meeting stating the matters to be considered to be given to all IWC members and posted and published in accordance with the Brown Act.

**5.5 Public Hearing.** At least annually, prior to publication of IWC's annual report, IWC shall conduct a public hearing on a draft of the IWC annual report. Each public hearing shall be conducted as part of a regular meeting.

**5.6 Agenda.** All meetings shall have a published agenda. Items for a regular meeting agenda may be submitted by any member to the chair and Alameda CTC staff. The Commission and/or Alameda CTC staff may also submit items for the agenda. Agenda planning meetings are held approximately three weeks prior to each IWC meeting. Alameda CTC staff will notify all IWC members when this meeting is established and remind members to submit any agenda item requests to the chair at least one day prior to the agenda planning meeting date. At the agenda planning meeting, the chair and Alameda CTC staff will discuss any agenda items submitted to the chair. Every agenda shall include a provision for members of the public to address the Committee. The chair and the vice chair shall review the agenda in advance of distribution. Copies of the agenda, with supporting material and the past meeting minutes, shall be mailed to members and any other interested parties who request it. The agenda shall be posted on the Alameda CTC website and in the Alameda CTC office and provided at the meeting, all in accordance with the Brown Act.

**5.7 Roberts Rules of Order.** The rules contained in the latest edition of "Roberts Rules of Order Newly Revised" shall govern the proceedings of the IWC and any subcommittees thereof to the extent that the person presiding over the proceeding determines that such formality is required to maintain order and make process, and to the extent that these actions are consistent with these bylaws.

**5.8 Place of Meetings.** IWC meetings shall be held at the Alameda CTC offices, unless otherwise designated by the Committee. Meeting locations shall be within Alameda County, accessible in compliance with the Americans with Disabilities Act of 1990 (41 U.S.C., Section 12132) or regulations promulgated thereunder, shall be accessible by public transportation, and shall not be in any facility that prohibits the admittance of any person, or persons, on the base of race, religious creed, color, national origin, ancestry, or sex, or where members of the public may not be present without making a payment or purchase.

**5.9 Meeting Conduct.** IWC members shall conduct themselves during meetings in a manner that encourages respectful behavior and provides a welcoming and safe environment for each member and staff member characterized by an atmosphere of mutual trust and respect. Members shall work with each other and staff to respectfully, fairly, and courteously deal with conflicts if they arise.

### Article 6: Subcommittees

**6.1 Establishment.** The IWC may establish subcommittees when advisable and as necessary subject to the approved Alameda CTC overall work program and budget as approved by the Commission to conduct an investigation or to draft a report or other document within the authority of the IWC or for other purposes within the IWC's authority.

**6.2 Membership.** IWC members will be appointed to subcommittees by the IWC or by the chair. No subcommittee shall have fewer than three members, nor will a subcommittee have sufficient members to constitute a quorum of the IWC.

#### Article 7: Records and Notices

**7.1 Minutes.** Minutes of all meetings, including actions and the time and place of holding each meeting, shall be kept on file at the Alameda CTC office. Alameda CTC staff will prepare and include full minutes in meeting packets prior to each regular IWC meeting.

**7.2 Attendance Roster.** A member roster and a record of member attendance shall be kept on file at the Alameda CTC office.

**7.3 Brown Act.** All meetings of the IWC will comply with the requirements of the Brown Act. Notice of meetings and agendas will be given to all members and any member of the public requesting such notice in writing and shall be posted at the Alameda CTC office at least 72 hours prior to each meeting. Members of the public may address the IWC on any matter not on the agenda and on each matter listed on the agenda, in compliance with the Brown Act and time limits, up to three minutes per speaker, set at the discretion of the chair.

**7.4 Meeting Notices.** Meeting notices shall be in writing and shall be issued via U.S. Postal Service, Alameda CTC website, personal delivery, and/or email. Any other notice required or permitted to be given under these bylaws may be given by any of these means.

#### **Article 8: General Matters**

**8.1 Per Diems.** Committee members shall be entitled to a per diem stipend for meetings attended in amounts and in accordance with policies established by the Alameda CTC.

**8.2 Conflicts of Interest.** A conflict of interest exists when any Committee member has, or represents, a financial interest in the matter before the Committee. Such direct interest must be significant or personal. In the event of a conflict of interest, the Committee member shall declare the conflict, recuse himself or herself from the discussion, and shall not vote on that item. Failure to comply with these provisions shall be grounds for removal from the Committee.

**8.3 Amendments to Bylaws.** These bylaws will be reviewed annually, and may be amended, repealed, or altered, in whole or in part, by a vote taken at a duly constituted Committee meeting at which a quorum is present, as a recommendation to the Commission for approval.

**8.4 Public Statements.** No member of the Committee may make public statements on behalf of the Committee without authorization by affirmative vote of the Committee, except the chair, or in his or her place the vice chair, when making a regular report of the Committee activities and concerns to the Alameda CTC. This does not include presentations about the Committee to city councils, which all Committee members have a responsibility to make.

**8.5 Conflict with Governing Documents.** In the event of any conflict between these bylaws and the July 2000 Transportation Expenditure Plan, the January 2014 Transportation Expenditure Plan, California state law, or any action lawfully taken by ACTIA or the Alameda CTC, the Transportation Expenditure Plans, state law or the lawful action of ACTIA or the Alameda CTC shall prevail.

**8.6 Staffing.** Alameda CTC will provide staffing to the Committee including preparation and distribution of meeting agendas, packets, and minutes; tracking of attendance; and stipend administration.

**8.7 Economic Interest.** Each Committee member shall, no later than March 15 of every year, prepare and file with Alameda CTC a statement of economic interest in the form required by law, currently Form 700 which can be found on the California Fair Political Practices Commission website, <u>http://www.fppc.ca.gov/index.php?id=500</u>.

# Independent Watchdog Committee Issues Identification Process<sup>10.2</sup>

#### Summary

This issues identification process outlines the responsibilities of the Independent Watchdog Committee (IWC) and identifies the process for IWC members and members of the public to bring issues of concern to the IWC and for IWC to address issues identified on "IWC Issues Forms" (attached).

#### **IWC Responsibilities**

The Independent Watchdog Committee is charged with the following as written in the 2000 and 2014 Transportation Expenditure Plans approved by voters.

The Independent Watchdog Committee is appointed pursuant to Measure B and Measure BB to review all expenditures of the Measure B transportation sales tax, to review and oversee all expenditures and performance measures, as appropriate, of the Measure BB transportation sales tax and to monitor Measure B and Measure BB projects and programs. This committee reports directly to the public and has the following responsibilities:

- Hold public hearings and issue reports, on at least an annual basis, to inform Alameda County residents about how the sales tax funds are being spent. The hearings are open to the public and must be held in compliance with the Brown Act, California's open meeting law, with information announcing the hearings well-publicized and posted in advance.
- Have full access to Alameda CTC's independent auditor and have the authority to request and review specific information regarding use of the sales tax funds and to comment on the auditor's reports.
- Publish an independent annual report, including any concerns the committee has about audits it reviews. The report will be published in local newspapers and will be made available to the public in a variety of forums to ensure access to this information.
- Provide a balance of viewpoints, geography, age, gender, ethnicity and income status, to represent the different perspectives of the residents of the county.

#### **Review Process**

The purpose for the review of projects and programs by the IWC is to report to the public on findings. To this end, the tasks on which the IWC should focus during review include:

- 1. Proper expenditure of Measure B and Measure BB funds;
- 2. The timely delivery of projects per contract agreements; and
- 3. Compliance with the projects or programs as defined in the voter-approved 2000 and 2014 Transportation Expenditure Plans.

During the review process, IWC members will adhere to the following procedures:

- Issues raised on an IWC Issues Form regarding Measure B or Measure BB expenditures and/or contract compliance on a project or program may be eligible to be pursued through a request for the project or program sponsor to appear before the IWC. Issues raised by members of the public regarding Measure B and/or Measure BB expenditures must be submitted in writing either to the IWC chair, vice-chair or to the committee at an IWC meeting.
- 2. Before requesting that staff respond to an issue or calling on a project or program sponsor to appear before the IWC, an IWC member must submit an IWC Issues Form to the IWC chair or vice-chair for placement on the agenda at the next IWC meeting. Issues submitted by a member of the public must be handled in the same manner.

#### **Review Process** (continued)

- 3. The IWC must approve, by an affirmative vote, the method taken to address an issue identified on an IWC Issues Form, whether originally presented by an IWC member or a member of the public.
- 4. The IWC may establish a subcommittee, when necessary, to address the issue, question, or concern raised on an IWC Issues Form.
- 5. The IWC or subcommittee should consider the resources listed below when addressing an issue raised on an IWC Issues Form.
- 6. If requested, staff shall respond in writing to the issue.

The reviews are expected to be organized, thorough and efficient, and may result in a clear recommendation for further action, if needed.

#### Resources for IWC (not all inclusive)

- Adopted 2000 and 2014 Transportation Expenditure Plans
- Up-to-date list of project/program sponsors contacts
- Alameda CTC staff responsible for oversight of the project/program or other expenditures
- Information about public hearings, recent discussions, or news clippings provided by Alameda CTC staff to the IWC by mail or at meetings
- Other Alameda CTC advisory committees (for example, Paratransit Advisory and Planning Committee or Bicycle and Pedestrian Advisory Committee chair-persons may be called on to address an issue)
- Alameda CTC independent auditor and Comprehensive Annual Financial Reports
- Alameda CTC General Counsel
