Alameda CTC Sale Tax Programs

Measure B (MB)

- In 1986, voters approved Measure B half-cent sales tax
- In 2000, Measure B reauthorized with 81.5% voter approval rate

Measure BB (MBB)


- In 2014, voters approved Measure BB to augment and extend the existing sales tax measure
- Collections started in April 2015


DLD Program Overview




- Over 50% of net revenues generated from the Measure B and Measure BB Programs are returned to source as "Direct Local Distributions" (DLDs)
- Twenty recipients (cities, transit agencies and the County)
- DLD Programs
 - Bicycle/Pedestrian
 - Local Streets and Roads (local transportation)
 - > Transit
 - > Special Transportation for Seniors and People with Disabilities (Paratransit)



Current Discretionary Program Status

- In July, Commission approved 2022 CIP
 - Included \$9.9M in Measure B Discretionary funds Bike/Ped, Transit, and Transit Oriented Development Program Funds
 - Alameda CTC will enter into funding agreements with the recipients
- Measure BB discretionary funds will be programmed with the next CIP programming cycle in 2022

<u>City of San Leandro</u> San Leandro Rehabilitation Project

Project Description:

San Leandro Rehabilitation project will repair and/or replace pavement on existing streets within the city. Work may include repair or replacement of road base, adjustment of utility lines and structures, replacement of striping, and installation of ADA complaint curb ramps.

<u>City of Emeryville</u> South Bayfront Bridge Bike/Pedestrian Bridge

Project Description:

Construct 227 foot-long steel tied-arch pedestrian/bicycle bridge over the Union Pacific Railroad (UPRR) tracks with concrete approach ramps

Total Cost	\$22.1	M

Project Description:

Safe Routes to School Mini-grant awards to cities and the County of Alameda to implement safety improvements around schools.

All cities were provided an opportunity to secure formula based mini-grants for capital improvements.
