Winner Announced in Alameda County Safe Routes to Schools' Golden Sneaker Contest for Students

Contest recognizing school-aged students who choose active transportation, carpooling and supportive mobility devices totaled over 15,000 students and more than 80 schools this year.

ALAMEDA COUNTY, Calif. – The <u>Alameda County Safe Routes to Schools (SR2S) Program</u> is celebrating the success of one of its core countywide events: the Golden Sneaker Contest. At the Alameda County Transportation Commission (Alameda CTC)'s most recent meeting, Commission Vice Chair and City of Alameda Mayor Marilyn Ezzy Ashcraft awarded the Platinum Sneaker to Lockwood STEAM Academy, which is located in Oakland and part of the Oakland Unified School District (OUSD). Vice Chair Ezzy Ashcraft and fellow commissioners congratulated school's winning classroom, and lauded the SR2S Program in delivering one of its core encouragement events for school-aged youth.

The Golden Sneaker Contest is a popular annual tradition administered by Alameda CTC's SR2S Program. The program is a comprehensive and proven approach to increase safe walking and biking to school with the goals of reducing congestion and harmful pollutants around schools and increasing the safety and physical activity of students. This year, over 80 schools registered for the event and participated between March 3rd and March 14th. The contest mobilized over 15,000 students throughout Alameda County into active travel for the trip to school.

During the contest, Alameda County students, classrooms, and schools competed to see who could use active and shared transportation the most, receiving points every time they walked, rolled, bicycled, rode a scooter or skateboard, took transit, or used a supportive mobility device such as a wheelchair. Teachers polled their classrooms and tallied the number of students who used active and shared modes during the event week. The classroom at each school with the highest rate of active travel was awarded the Golden Sneaker Award. The school with the highest average classroom participation in all of Alameda County received the Platinum Sneaker Award.

An average of 65% of Platinum Sneaker-winning Lockwood STEAM Academy students took an active or shared transportation option to school during the contest. This included 24 classrooms and approximately 574 students. The winning classroom was Ms. Brynna Price's 3-5th grade Special Education class, with 94%

participation. Alameda CTC extends a special thank you to the Lockwood STEAM Academy Safe Routes Champion, Rose Chardak, and school vice principal, Roberto Lascon, for bringing the SR2S Program and their award-winning participation to their school.
